

ITEM TITLE:

Ordinance on Second Reading. Zoning Code Text Amendment. An Ordinance of the City Commission of Coral Gables, Florida providing for a text amendment to the City of Coral Gables Official Zoning Code, Article 4, "Zoning Districts," Division 4, "Prohibited Uses," Section 4-411, "Parking in residential areas;" amending the provisions for loading and unloading of commercial vehicles within residential districts and within a specified distance of residential districts; providing for repealer provision, severability clause, codification, and providing for an effective date.

DEPARTMENT HEAD RECOMMENDATION:

PLANNING AND ZONING BOARD RECOMMENDATION:

The Planning and Zoning Board at their 10.19.16 meeting recommended approval (vote: 5-0).

BRIEF HISTORY:

Since First Reading, the Ordinance has been updated to allow loading and unloading outside of the permissible hours of 7 am to 7 pm so long as the special waiver is for good cause. Also, the two (2) hour limit does not apply to the loading and unloading of residential moving trucks.

On November 15, 2016 the City Commission approved the Zoning Code text amendment (vote: 5-0) amending the provisions for loading and unloading of commercial vehicles within residential districts on first reading with proposed changes. The Zoning Code text amendment, including the changes requested by the City Commission at 1st Reading, is provided in the draft Ordinance in strikethrough/underline format attached as Exhibit A.

Currently, the loading or unloading of trucks, trailers or commercial vehicles is allowed within residential districts, provided that such loading or unloading takes less than two (2) hours and occurs between the hours of 7:00 AM and 7:00 PM. The proposed amendment would leave these restrictions in place and add a provision that they would apply to all properties within one-hundred (100) feet of residential districts.
