City Manager Swanson-Rivenbark: So, Peter, do you want to present this one? This is standard operating procedure for FDOT, in that when we're coming in with decorative pavers in these locations, then we need to assume the maintenance for it. We've reviewed it with you all individually. There's nothing out of the ordinary with this, and we're recommending approval. But Peter, if you had any specific comments...

Assistant City Manager Iglesias: Madam Manager, what she says is 100 percent correct. This is a standard agreement for pavers along -- that are parallel to the -- Le Jeune Road. And it's a standard agreement that we maintain the pavers and also a certain connection -- we'll have another agreement for drainage connection. This is just a standard DOT agreement.
