

ITEM TITLE:

Resolution. Conditional Use Review. A Resolution of the City Commission of Coral Gables, Florida granting conditional use approval pursuant to Zoning Code Article 3, "Development Review," Division 4, "Conditional Uses," and Article 4, "Zoning Districts," Division 3, "Nonresidential Districts," Section 4-301, "Commercial Limited District," for the University of St. Augustine to allow greater than fifty (50) student seats within a Commercial Limited (CL) zoned district for the property legally described as Blocks 1, 2 and 4, Douglas Entrance (800 Douglas Road), Coral Gables, Florida; including required conditions and providing for an effective date.

DEPARTMENT HEAD RECOMMENDATION:

Approval with conditions.

PLANNING AND ZONING BOARD RECOMMENDATION:

The Planning and Zoning Board at their 02.01.17 meeting recommended approval (vote: 7 - 0) with conditions.

BRIEF HISTORY:

The request is for conditional use site plan review in order to allow the University of St. Augustine to operate an educational facility of greater than fifty (50) student seats on property zoned Commercial Limited (CL) District, which is permitted as a conditional use, within the Annex Building at Douglas Entrance located at 800 Douglas Road.

The Applicant is proposing a change of use within the existing 2-story building with the address 3790 SW 8th Street, referred to as the "Annex Building at Douglas Entrance," to utilize the 53,201 sq. ft. space as a university with a maximum total of 390 students on campus utilizing 200 student stations. University employees and students that drive will park in the existing garage located at Galiano Street.
