Mrs. Morris brought the meeting to order at 8:35 a.m.

## 4. Smoking Regulations (Discussion)

Javier Betancourt provided a quick update regarding his conversation with the City Attorney's office about looking into outlawing smoking in the public right of way. There is state preemption language that prohibits municipalities from passing regulations dealing with outdoor smoking, however the City Attorney believes he may have a solution that would allow the City to do it on the City's own public rights of way, which would include City sidewalks and Giralda Plaza. The City Attorney will look into that but said it's perfectly acceptable if the board wishes to make a recommendation to the City Commission to explore and pursue that initiative. Mrs. Morris expressed her strong feelings against smoking and said that the outdoor dining experience is completely diminished when someone lights up, adding that we live in an enlightened age where we know that secondhand smoking causes cancer, and that if the City is going to ban Styrofoam, she believes it to be within the City's capacity to ban smoking on the sidewalks too.

Ms. Ramudo made a motion requesting for the City Commission to have the City explore the prohibition of smoking in outdoor dining areas located in the public right of way, which was seconded by Mr. Sime, and which passed unanimously.

Upon hearing this item, Mr. Fernandez of the Property Advisory Board asked if his board could join in on the motion, which was well received and deemed important by other PAB members.

Mr. Fernandez made the same motion, requesting for the City Commission to have the City explore the prohibition of smoking in outdoor dining areas located in the public rights of way, which was seconded by Ms. Molina, and which passed unanimously.

The meeting was adjourned at 10:18 a.m.
