

**City of Coral Gables CITY COMMISSION MEETING July 11, 2017** 

## **ITEM TITLE:**

**Resolution.** Amendment to Village of Merrick Park Site Plan Review. A Resolution of the City Commission of Coral Gables, Florida granting site plan approval pursuant to Zoning Code Article 3, "Development Review," Division 4, "Conditional Uses," Section 3-402, "General procedures for conditional uses," for an Amendment to the Village of Merrick Park Site Plan for the development project referred to as "Merrick Park Hotel" on the property legally described as Lots 12-22, Block 6, Industrial Section (4241 Aurora Street), Coral Gables, Florida; including required conditions and providing for an effective date.

### **DEPARTMENT HEAD RECOMMENDATION:**

Approval with conditions.

### PLANNING AND ZONING BOARD RECOMMENDATION:

The Planning and Zoning Board at their 05.10.17 meeting recommended approval (vote: 6 - 0) with conditions.

### **BRIEF HISTORY:**

The Application request is for conditional use with site plan review in order to amend the Village of Merrick Park site plan by adding the project referred to as the "Merrick Park Hotel." This parcel is being added to the original site plan approval, which was originally approved on 12.18.1998, in order to optimize the use of parking throughout the Village of Merrick Park site, as no parking is proposed for onsite. The Merrick Park Hotel will have restaurants, retail and 135 hotel rooms.

The property is within the City's Industrial Section and includes the half of the block bounded by Aurora Street (west), Altara Avenue (north) and San Lorenzo Avenue (south). The site is currently vacant with the Village of Merrick Park located to the west and south of the property and existing one (1) story commercial buildings adjacent to the property to the east.
