Before that I was employed as an Accounting Manager with the University of Miami. During my time with the University of Miami, I was in charge of overseeing the retirement audits for each of four retirement plans the University offered. My exposure included being intimately involved in assessing each plan's financial health, investment strategies, and fiduciary compliance with federal authorities.
