A RESOLUTION GRANTING PERMISSION TO MAKE-A-WISH SOUTHERN FLORIDA TO SELL ALCOHOLIC BEVERAGES AT THE PARKING LOT LOCATED ON 1159 SUNSET DRIVE ON SATURDAY, MARCH 11, 2017, FROM 12:00 P.M. TO 4:00 P.M., DURING THE "WINGS FOR WISHES" EVENT TO BENEFIT THE MAKE A WISH SOUTH FLORIDA, SUBJECT TO FLORIDA DEPARTMENT OF PROFESSIONAL REGULATION REQUIREMENTS.

BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. That the City Commission does hereby grant permission to Make a Wish South Florida to serve alcoholic beverages during the "Wings for Wishes" event and is in compliance with the laws of the State of Florida.

SECTION 2. That the event will take place at the parking lot located on 1159 Sunset Drive on Saturday, March 11, 2017, from 12:00 p.m. to 4:00 p.m. "Wings For Wishes" is a fun event hosted by Make-A-Wish Southern Florida by local professionals committed to making life better for children with life-threatening medical conditions. In its first two years, the event raised more than \$50,000 to grant wishes. The 2017 event will be larger and more vibrant than before. The event will take place behind Sports Grill South Miami and will be in a 'block party' format with a wing tasting component in addition to the crowd-favorite wing eating competition. Sports Grill will feature six different tasting stations, while patrons will be able to pair their food with a variety of different craft beers and/or wine. The afternoon will feature live music, a DJ, and plenty of fun events for children and adults alike. One hundred percent (100%) of the proceeds benefit Make-A-Wish Southern Florida.

SECTION 3. This request has been reviewed by the City's Special Events Committee.

SECTION 4. That this resolution shall become effective upon the date of its passage and adoption herein.
