RESOLUTION NO. 2017-74

A RESOLUTION ACCEPTING THE RECOMMENDATION OF THE CHIEF PROCUREMENT OFFICER TO APPROVE A CONTRACT WITH AECOM TECHNICAL SERVICES, INC., IN THE AMOUNT OF \$2,748,165 FOR PUBLIC SAFETY BUILDING DESIGN CONSULTING SERVICES PURSUANT TO FLORIDA STATUTE 287.055, KNOWN AS THE "CONSULTANTS COMPETITIVE NEGOTIATION ACT" AND REQUEST FOR QUALIFICATIONS (RFQ) 2016.05.MG.

WHEREAS, on December 6, 2016, the City Commission authorized negotiations for a contract with AECOM Technical Services, Inc., selected as a result of an RFQ process, as the design consulting firm for a new Public Safety Building; and

WHEREAS, the purpose of this contract is to hire a qualified design consultant to prepare and provide all plans and construction administration services, to include programming, schematic design development, construction documents, and construction administration for a new Public Safety Building; and

WHEREAS, the Public Works Department, the Public Safety Director, and the Procurement Division have completed their contract negotiations with AECOM Technical Services, Inc.; and

WHEREAS, the Chief Procurement Officer in consultation with the Public Works Director and the Public Safety Director, recommends that a contract with AECOM Technical Services, Inc. be approved; and

WHEREAS, Section 2-650 of the Procurement Code authorizes the City Manager to delegate authority to the Chief Procurement Officer to administer and make recommendations on City contracts;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. That the City Commission accepts the recommendation of the Chief Procurement Officer to approve a proposed contract with AECOM Technical Services, Inc., in the amount of \$2,748,165 for Public Safety Building Design Consulting Services pursuant to Florida Statute 287.055, known as the "Consultants Competitive Negotiation Act" and Request for Qualifications (RFQ) 2016.05.MG, in substantially the form attached, with such modifications as approved by the City Manager and the City Attorney in order to accomplish the Commission's intent, and provided that (i) the proposed contract shall not be executed until the Agreement of Purchase and Sale between the City and C/LeJeune, LLC (the "Purchase and Sale Agreement") for, in part, the City's acquisition of the property located under folio #03-4108-006-1730, known to the City as the "Minorca Parcel," has been executed; and (ii) the City Commission shall have the right to terminate the contract in the event the City does not acquire the Minorca Parcel in accordance with the terms and provisions of the Purchase and Sale Agreement.

SECTION 3. That this Resolution shall become effective upon the date of its passage and adoption herein.
