## **RESOLUTION NO. 2017-208**

A RESOLUTION AUTHORIZING AN AMENDMENT TO THE FISCAL YEAR 2016-2017 ANNUAL BUDGET TO RECOGNIZE AS REVENUE A \$5,200,000 TRANSFER FROM CAPITAL IMPROVEMENT FUND BALANCE, AND TO APPROPRIATE SUCH FUNDS TO PUT TOWARD THE COST OF THE TROLLEY DEPOT/FIRE STATION 2 BUILDING CONSTRUCTION PROJECT.

WHEREAS, the Fiscal Year 2017-2021 Capital Improvement Plan includes the Trolley Depot/Fire Station 2 Building project commencement in Fiscal Year 2017-2018 and funded by a combination of the Trolley Depot settlement funds as well as outside financing; and

WHEREAS, the project is anticipated to start during Fiscal Year 2016-2017, thereby requiring in this year the appropriation of the \$3,900,000 settlement held in fund balance as well as an additional appropriation of \$5,200,000 from unrestricted General Capital Improvement funds; and

WHEREAS, Resolution 2017-73 approved by the Commission on March 28, 2017 authorized an amendment to the Fiscal Year 2016-2017 annual budget to transfer from fund balance and appropriate the \$3,900,000 settlement; and

WHEREAS, the City has accumulated unrestricted fund balance in the General Capital Improvement Fund with the purpose of funding large capital infrastructure projects; and

WHEREAS, it has been determined to use available unrestricted Capital Improvement Fund Balance in place of outside financing; and

**WHEREAS**, an additional amendment to the Fiscal Year 2016-2017 annual budget is required to recognize as revenue a \$5,200,000 transfer from Capital Improvement Fund Balance and to appropriate such funds to put toward the cost of the project;

## NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

**SECTION 1.** That the foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon the adoption hereof.

**SECTION 2.** The City Commission does hereby authorize an amendment to the Fiscal Year 2016-2017 annual budget to recognize as revenue the \$5,200,000 transfer from Capital Improvement Fund Balance and to appropriate such funds to put toward the cost of the Trolley Depot/Fire Station 2 Building Construction project.

**SECTION 3.** That this resolution shall become effective upon the date of its passage and adoption herein.
