**RESOLUTION NO. 2017-246**

A RESOLUTION WITH ATTACHMENT(S), OF THE CITY COMMISSION CONFIRMING THE ELECTION OF THOMAS "TOM" ZELENAK TO THE CITY OF CORAL GABLES RETIREMENT BOARD, AT-LARGE PARTICIPATING REGULAR FULL-TIME EMPLOYEE REPRESENTATIVE), SEAT FOR THE REMAINDER OF AN UNEXPIRED TERM WHICH BEGAN JANUARY 1, 2016 THROUGH DECEMBER 31, 2017.

**WHEREAS**, on Thursday, May 18, 2017, nominating petitions forms were distributed with employees' paycheck to each department/division, within the City of Coral Gables to nominate a candidate for the At-Large Participating Regular Full-time employee seat; and

**WHEREAS**, as of the Friday, June 2, 2017, 5:00 p.m., deadline for submittal of nominating petition forms for candidates to the Coral Gables Retirement Board, five individuals who were qualified to run for the At-Large Participating Regular Full-time employee seat were nominated, namely Cesar Canas, Jesus Cordero, Mitrand Bhagirathi, Steven Rodriguez and Tom Zelenak; and

**WHEREAS**, on Friday, June 9, 2017, following the canvass of the vote count of the total votes cast, Thomas "Tom" Zelenak was elected and declared the winner;

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES, FLORIDA:**

**SECTION 1.** The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution upon adoption hereof.

**SECTION 2.** That the City Commission does hereby confirm Thomas "Tom" Zelenak as a member of the Coral Gables Retirement Board for the remainder of an unexpired term which began January 1, 2016 through December 31, 2017.

**SECTION 3.** That this Resolution shall become effective upon its passage and adoption herein.
