A Resolution accepting the recommendations of the Chief Procurement Officer to award the Trolley Operations Service Contract to MV Transportation, Inc. the most responsive and responsible proposer, at an estimated annual amount of \$\$953,080, subject to change per Miami-Dade County Living Wage rate adjustments, not to exceed budgeted available funds, for a period of two (2) years with option to renew for two (2) additional two (2) year periods exercisable at the option of the City Manager, pursuant to Section 2-828 of the Procurement Code entitled "Contract Award" and Request for Proposals (RFP) 2017.03.MS; should negotiations fail with the most responsive-responsible proposer, negotiations shall commence with the next most responsive-responsible proposer until an agreement and contract amount acceptable to the City has been reached. (This contract is funded 100% by CITT – Half-Cent Transportation Surtax. This contract is increasing from prior year by approximately \$103,153 due to a \$418 hourly rate increase submitted by the most responsive-responsible proposer.)

Mayor Valdes-Fauli: Next item is I-4, Mr. City Attorney would you read the resolution, I-4.

City Attorney Leen: This is a Resolution accepting the recommendation of the Chief Procurement Officer regarding the trolley operation services. This resolution doesn't need to be

read into the record, Madam Finance Director.

Finance Director Gomez: Good afternoon. This is a resolution accepting the recommendation of

the Chief Procurement Officer to award trolley operations services contract to MV Transportation, Inc., the most responsive and responsible proposer at an estimated annual

amount of \$953,080, subject to change per Miami-Dade County Living Wage rate adjustments,

not to exceed the budgeted available funds...

City Attorney Leen: As mentioned, it doesn't need to be read because it's a resolution.

Finance Director Gomez: The purpose of this trolley operation services contract is to hire a

qualified transportation company to provide trained and licensed trolley drivers, dispatchers and supervisors to operate the City-owned trolley system. Three proposals were received and the

evaluation committee convened and evaluated the three proposals and deemed the MV

Transportation is the top-ranked responsive and responsible proposer. The contract will be

funded 100 percent by CITT Half-Cent Transportation Surtax and this contract is increasing from prior year by approximately \$103,000 due to a \$4.18 hourly rate submitted by the most

responsive bidder. You have any questions?

Mayor Valdes-Fauli: Yes, tell me about it.

Finance Director Gomez: Tell you about...?

Mayor Valdes-Fauli: What they are going to propose, what are they going to return to us in

exchange for a million dollars?

Finance Director Gomez: So what they provide is all of the trolley operation drivers. I'm going

to have Kevin Kinney explain.

Parking Director Kinney: So right now five days a week including holidays, Monday through

Friday, we provide seven trolleys that run up and down Ponce and one trolley that goes down to the MacFarlane Homestead area. This contract is for drivers and dispatchers only. The maintenance of our trolleys is done by the fleet services division of the City. So the 210 days that

the trolley operates this contract provides, I believe the rate is \$38.59 per hour, drivers that drive

all of our trolleys.
