Commissioner Lago: Yes.

Mayor Cason: Slesnick, this is your item.

F. W. Zeke Guilford: Mr. Mayor, Commissioners, thank you very much.

Mayor Cason: Thank you. F-1's a resolution.

Commissioner Slesnick: Yes. Excuse me, Mr. City Attorney.

City Attorney Leen: Yes, Commissioner.

Commissioner Slesnick: I'm sorry. I wanted to bring this up. The Dade County has approved this in April, a resolution to urge the U. S. Army Corps of Engineers to expedite Phase II of the Biscayne Bay Coastal Wetlands, and I'd like to have Irela Bague -- I'm sorry, come on up to -- who is on our Sustainability Committee and -- young lady?

Carissa DeCramer: Carissa DeCramer.

Commissioner Slesnick: If you could just -- briefly, yes.

Ms. DeCramer: Yes, and I have a speaker card that I have submitted.

Mayor Cason: Thank you. You may proceed unfettered.

Ms. DeCramer: Your system works.

Mayor Cason: So ordered.

Ms. DeCramer: Alright, well, thank you so much for taking this up. I know -- I will be very brief, because I know that...

Vice Mayor Quesada: Take your time. We've made you wait too long.

Ms. DeCramer: So, I -- my name is Carissa DeCramer. I'm the chief of staff at Biscayne National Park. Biscayne National Park is one of four national parks located right here in South Florida. It's just a stone's throw away. But the park is actually 95 percent water, so water is a big deal to our national park. And as you mentioned, this resolution is to encourage the Army Corps of Engineers to re-evaluate the planning timetable of the Biscayne Bay Coastal Wetlands Project. Right now, that project is planned to -- there's two phases. The first phase will not be complete until 2021. And the second phase will not start until 2020 and not be completed until 2026. That has significant impacts for two major reasons. The first reason is fresh water is key to the resources of Biscayne National Park. We have fresh water that feeds from land, feeds directly into the bay that helps balance the bay and the saltwater in the bay. That's important, because 70 percent of the fish, crustaceans and shellfish that we recreationally and commercially enjoy in this area all grow up right in Biscayne Bay. So, if we have that imbalance right in Biscayne Bay, because there's too much saltwater and not enough fresh water, then we start to get out of whack and we have all sorts of other issues. So, in expediting this project, it hopes to address the balance of the saltwater in that piece. The second major piece is that national parks are economic powerhouses. Last year alone, Biscayne National Park brought \$32 million to the local economy and created 450 jobs for the greater tourism industry. That's important to this area. That's important to the economics. It's important for jobs such as those folks that live in Coral Gables. It also feeds into the quality of life, because many folks enjoy going out...

Mayor Cason: Fishing.

Ms. DeCramer: Boating and fishing...

Mayor Cason: Fishing, that's me.

Commissioner Keon: It's like our biggest playground.

Ms. DeCramer: Exactly.

Commissioner Keon: Yes.

Ms. DeCramer: So, this project is important to maintain that good, healthy ecosystem. And we hope that in your resolution that it helps expedite that timeline so that we can get the funding that we need invested right here in our local national park and can kind a get this project started.

Mayor Cason: Well said, well spoken.

Commissioner Keon: Is this national funding or is it...

Ms. DeCramer: Army Corps of Engineers.

Commissioner Keon: It's federal funding or...

Ms. DeCramer: Federal funding.

Commissioner Keon: State funding?

Ms. DeCramer: Federal.

Commissioner Keon: It's all federal funding.

Ms. DeCramer: Federal funding.
