City Attorney Leen: Yes Mr. Mayor. Item E-5 -- This is an Ordinance on First Reading, it's an Ordinance of the City Commission of Coral Gables, Florida providing for a text amendment to the City of Coral Gables Official Zoning Code by amending Article 4, "Zoning Districts,"

Division 3, "Nonresidential Districts," Section 4-302, "Commercial District," and Article 5, "Development Standards," Division 1, "Accessory Uses," Section 5-115, "Drive-throughs, walk-up windows, and automated teller machines (ATM)" requiring conditional use review for drive through facilities providing for a repealer provision, severability clause, codification, and providing for an effective date. This item was recommended by the Planning and Zoning Board on November 9, 2016 by a vote of 6-0, and before Mr. Trias begins and he has a presentation for you, I just wanted to add that obviously this addresses drive-throughs. This ordinance is not intended to address the specific situation going on right now with the Starbucks drive-through. It is intended to address current drive-throughs if they have a future violation and also any new drive-throughs that come into town. With that I would turn it over to the City Manager and Mr. Trias.

Planning and Zoning Director Trias: Mayor very straightforward, it's simply that drive-throughs from now on will be a conditional use and will be reviewed with information about traffic and operations, hopefully to enhance the future operations of travelers.

Mayor Cason: So basically, you are giving the City Commission a chance to look at it and see in the context of everything whether we are going to approve it or not?

Planning and Zoning Director Trias: Yes.
