

## **ITEM TITLE:**

# Ordinance on First Reading. Comprehensive Plan Text Amendment.

1. An Ordinance of the City Commission of Coral Gables, Florida requesting an amendment to the text of the City of Coral Gables Comprehensive Plan, to include a Coastal Management Element, pursuant to expedited state review procedures (S.163.3184, Florida Statues) and Zoning Code Article 3, "Development Review," Division 15, "Comprehensive Plan Text and Map Amendments;" to include Objectives and Policies to protect coastal areas of the city; providing for a repealer provision, providing for a severability clause, and providing for an effective date.

Transmit the proposed amendments to Department of Economic Opportunity (DEO).

# **BRIEF HISTORY:**

## **Project Summary**

The proposed amendments are required by the Evaluation and Appraisal Report (EAR) process of the Comprehensive Plan, established by state law. The EAR process updates local comprehensive plans, as required by new state legislation. Staff has determined that Comprehensive Plan text amendments are necessary to comply with recent changes on Chapter 163, Florida Statues.

The attached document has been prepared for transmittal to the Department of Economic Opportunity (DEO). Staff has coordinated with DEO staff and expects comments and suggestions. It is anticipated that the transmittal document will be revised as needed prior to adoption on Second Reading. DEO staff has stated that upon transmittal by the Commission, the Coral Gables Comprehensive Plan process will be in compliance with state requirements.
