### 1. APPLICATION REQUEST

The City of Coral Gables is requesting review and consideration of the following:

An Ordinance of the City Commission of Coral Gables, Florida requesting an amendment to the text of the City of Coral Gables Comprehensive Plan, to include a Coastal Management Element, pursuant to expedited state review procedures (S.163.3184, Florida Statues) and Zoning Code Article 3, "Development Review," Division 15, "Comprehensive Plan Text and Map Amendments;" to include Objectives and Policies to protect coastal areas of the city; providing for a repealer provision, providing for a severability clause, and providing for an effective date.

The proposed amendments are required by the Evaluation and Appraisal Report (EAR) process of the Comprehensive Plan, established by state law. The EAR process updates local comprehensive plans, as required by new state legislation. Staff has determined that Comprehensive Plan text amendments are necessary to comply with recent changes on Chapter 163, Florida Statues. In these text amendments, Staff is addressing the "Peril of Flood" requirements, as outlined in 163.3178(2)(f):

A redevelopment component that outlines the principles that must be used to eliminate inappropriate and unsafe development in the coastal areas when opportunities arise. The component must:

- 1. Include development and redevelopment principles, strategies, and engineering solutions that reduce the flood risk in coastal areas which results from high-tide events, storm surge, flash floods, stormwater runoff, and the related impacts of sea-level rise.
- 2. Encourage the use of best practices development and redevelopment principles, strategies, and engineering solutions that will result in the removal of coastal real property from flood zone designations established by the Federal Emergency Management Agency.
- 3. Identify site development techniques and best practices that may reduce losses due to flooding and claims made under flood insurance policies issued in this state.
- 4. Be consistent with, or more stringent than, the flood-resistant construction requirements in the Florida Building Code and applicable flood plain management regulations set forth in 44 C.F.R. part 60.
- 5. Require that any construction activities seaward of the coastal construction control lines established pursuant to s. 161.053 be consistent with chapter 161.

6. Encourage local governments to participate in the National Flood Insurance Program Community Rating System administered by the Federal Emergency Management Agency to achieve flood insurance premium discounts for their residents.

#### 2. PROPOSED ZONING CODE TEXT AMENDMENT

On November 8, 2017, the Planning & Zoning Board discussed a draft of the proposed Comprehensive Plan text amendment. The proposed amendment was presented to the City Commission on November 14, 2017; and unanimously approved on First Reading to transmit the proposed amendment to the Department of Economic Opportunity (DEO). Staff has incorporated comments, specifically as it relates to sea level rise, from various City departments; local experts; and the State. The revised proposed Comprehensive Plan text amendment is provided as Attachment A.

### 3. FINDINGS OF FACT
