City Clerk Foeman: Yes, they are working with Public Works and developing those legal

boundaries that will explain the legal description of what those waterways are. Jessica Keller

have been working with the IT Department.

Commissioner Lago: Madam City Manager when do you think we could potentially schedule our

first meeting, just to get an idea?

City Manager Swanson-Rivenbark: I don't think we have a quorum yet, so as soon as we have

the appropriate complement of the board. I know it has been very well received. I had an easier appointment because I don't have a geography and I don't have the water as the background. So

my appointment I'm hoping the Commission will confirm. Walter how many appointments are

we still awaiting?

City Clerk Foeman: We've had four names proffered so far, so we are still pending two

Commissioner Lago: I gave my name already.

City Clerk Foeman: Yes. I have yours.

City Manager Swanson-Rivenbark: We'll work with the individual Commissioners to get the full

complement and then we'll set it as soon as possible.

Commissioner Lago: Perfect. I think this board is going to bring a lot of insight to a much

needed issue that we've been having here.
