Presentation for a Neighborhood Renaissance Program Street Resurfacing Initiative for 2016 and a Resolution authorizing staff to proceed with such.

Mayor Cason: H-5.

City Manager Swanson-Rivenbark: Jessica you're on. I know Glenn is in a meeting, the street resurfacing initiative.

Ms. Keller: Good afternoon. I'm Jessica Keller, Assistant Public Works Director. This is the presentation of the Neighborhood Renaissance Program Street Resurfacing Initiative for 2016 and a Resolution authorizing the project. In 2011, the City engaged the engineering firm of Stantec, formerly C3TS, to evaluate the condition of all the City streets. Staff independently reviewed these streets and confirmed the findings. As a result, the City paved approximately 30 lane miles identified as "definitely" or "strong maybe" in need of resurfacing. The first phase of this resurfacing program resulted in significant and much needed improvements to the City's

aging streets. Our initial plan was to work through these streets over the next five to seven years

using gas tax revenues, but recently the opportunity to utilize additional NRP (Neighborhood Renaissance Program) dollars for the paving program became available and we are accelerating

the program to address a portion of these streets. The first phase of this year's program is focused

on the northern end of the City for efficiency and logistics. We do expect another round of

paving to occur later this year utilizing the normal gas tax funding. If you take a look at the

attachment and the map, it shows that the primary work will be concentrated between Coral Way

and Bird Road.

Mayor Cason: Good. We have good results with the first company, they did a good job.

Ms. Keller: Yes. We are actually using the same company to do the work and we have had good

success with them.

Mayor Cason: How many miles will they be able to do with this, do you think?

Ms. Keller: It would be approximately eight and-a-half lane miles.

Mayor Cason: Good.

Commissioner Lago: Let me ask you a quick question. I had a meeting with the residents from

Coco Plum and they were mentioning that they had some concerns. Does this encompass any of

their concerns?

Ms. Keller: Yes. We actually – we have some flexibility and we are concentrating between Coral

Way and Bird Road, but we are anticipating doing some repaying of Coco Plum, the main road.

Commissioner Lago: Many of the residents of Gables Estates also had some concerns, but it was

mostly Coco Plum, right?

Ms. Keller: Yes.

Mayor Cason: I remember the first round we had a couple of issues with the manhole covers and

then also the connection with the driveways and drainage and such, did they learn from that?- is

that going to be taken care of?

Ms. Keller: Yes. We'll be milling all of the streets and paving rather than just....

Mayor Cason: And if anybody has a complaint after they come by they can call and they'll come back and fix this or that. I think we had a few of those.
