Mayor Cason: Alright. The next item is E-1; this is an Ordinance on Second Reading, City Attorney, Item E-1.

City Attorney Leen: Thank you Mayor. Item E-1 is an Ordinance on Second Reading sponsored by Mayor Cason. An Ordinance of the City of Coral Gables, Florida prohibiting buttons and other encroachments in the public right-of-way without approval from the City directing the City to remove such unauthorized buttons and other encroachments from the right-of-way,

authorizing the City to bill the property owner for such removal as a special assessment, and providing for a repealer provision, severability clause, codification, enforcement and providing for an effective date. This is a Second Reading Ordinance. This is a public hearing item Mr. Mayor. Also, since this is your fifth year anniversary, I know this is a very important ordinance

for you and so I would turn it back over to you.

Mayor Cason: Do we have any speaker cards?

City Clerk Foeman: No Mr. Mayor.

Mayor Cason: So we'll close the public hearing. Anymore discussion?

Commissioner Keon: Does the provisions in our, I think it's in our City Code that allow people

to call to get no parking signs and all of that, all that section will be struck from our Code?

City Attorney Leen: The no parking signs?

Commissioner Keon: Do the encroachments, other encroachments where someone in the

neighborhood can call, and have a no parking sign placed in front of their home?

City Attorney Leen: That remains in the Code. If they put the no parking signs themselves this

would apply, but if it's an authorized no parking sign...Madam Manager.

City Manager Swanson-Rivenbark: Commissioner you are correct. We are revisiting no dumping, no trash, no parking signs, in addition to the buttons; we are going to look at them as a case-by-case basis. There will be some need to have that if it's approximate to Venetian Pool, but

it will not be just because somebody called in for that request.

Commissioner Keon: But, I know that now there are around the City in front of some homes, because they don't want their neighbors to park in front of their house, they have requested and

have gotten no parking signs, and I guess it's through our Parking Department that...

City Manager Swanson-Rivenbark: You are correct, and we are going to be dealing gently with those residents on pulling those signs back, and no longer allowing somebody to put a no parking

sign in front of their house, if it's just so that their neighbors won't be able to park.

Commissioner Keon: I understand around the Venetian Pool and those things, but there are other

areas where....in front of their house...

Mayor Cason: A lot of them may have been put in years and years ago, and the owner moved,

and sold the house, and the next person says why is this here?

City Manager Swanson-Rivenbark: And that's why we are going to handle it at the level that you

want, in terms of customer service.

Commissioner Keon: OK. So going forward we are not going to grant those signs unless you see

there – it's not just because they desire it, it's because there has to be something in the area.

City Manager Swanson-Rivenbark: A public safety public service need to have it and so, yes, the

Parking Department is revisiting all of those "no parking anytime" signs. At the same time, we

have done a very good job at resident parking permits only, and so we are going to be continuing

to do those resident parking permits.
