Karen Couty: Good morning.

Mayor Cason: Good morning.

Ms. Couty: Yes. I'm here representing the Cuban Classical Ballet of Miami. And forgive me, I did sort of step in. I've been working with them on and off for many years. I've been working with them many years, Mr. Peña, on and off. I was gone for the last two, so I stepped back in because of there were some changes in -- with the Cuban Classical Ballet of Miami, not just the Cuban Classical Ballet of Miami, but Mr. Peña has now the Miami Hispanic Cultural Arts

Center. And one of the missions that he's always had is trying to reach out to the community and get more involved in other areas of the community.

Vice Mayor Quesada: I'm sorry. I just want to clarify. Are you with the Cuban Classical

Ballet?

Ms. Couty: Yes, I'm...

Vice Mayor Quesada: Okay.

Ms. Couty: Representing them. I'm sorry.

Vice Mayor Quesada: No, don't worry. Did you...

Ms. Couty: I just stepped back in, though, this past December. I hadn't been working with them. And anyone who knows Mr. Peña over the many years, he's a very dedicated person.

And this was a huge oversight. A lot of things happened last year. I wasn't there. However,

with the advent of obtaining this house and the Miami Hispanic Cultural Arts Center and the

many things that he does, Mr. Jimenez, who is the choreographer and the ballet master of the

Cuban Classical Ballet, also had to go away to Colombia for a few months. His father was

passing away. There was a lot of things that happened. They rehearsed something -- I'm not

aware of everything. Our grant writer had left, and apparently, there was miscommunication.

Anyway, when I became aware of this in January -- I was to go to a meeting of the Arts Council

for Coral Gables to discuss the funds that were allocated for this, performances here. And they --

that was cancelled, so I was -- I just went -- was ready to go to the next one a month later and

state the case because Mr. Jimenez had arranged with the Coral Gables Music Club and at the

Coral Gables Congressional Church -- I have some photos...

Vice Mayor Quesada: Let me just stop you for a second. I just want to understand where we're

at here. Let me just -- if you could just bear with me for one second. So, I'm assuming that

you're appearing before us today so that we don't require you to return the \$2,500. Is my

assumption correct?

Ms. Couty: Well, yes, because basically...

Vice Mayor Quesada: Okay.

Ms. Couty: It was allocated and they did do a performance and they have two more scheduled.

These are free performances.

Vice Mayor Quesada: But hold on. So, then you're saying within the fiscal year of 2014-2015 --

I'm sorry, for performance within 2015-2016, you're saying a performance took place in Coral

Gables with that \$2,500?

Ms. Couty: Yes, yes. This past May 18.

Vice Mayor Quesada: Can I get a representative from the board to clarify this because my

understanding was that that did not occur. So, here's our big concern -- and if I could just sort of

set the stage because you don't have the agenda in front of you. We allocate monies to different

cultural organizations throughout the city to have events within the city or have other cultural

experiences within the city. We allocated \$2,500 to the Cuban Classical Ballet and no event --

my understanding, no event took place. Now, if we're allocating funds from taxpayer funds

from taxpayer money for cultural events within the city, which we take very seriously and no

event takes place, in my opinion, that's the most egregious conduct that could occur, and we're

absolutely going to request that money back. So, I just want to clarify. If you're saying an event

took place and my facts are mistaken, then obviously, I want to know. That's why I've asked

representatives from the board...

Ms. Couty: Correct.

Vice Mayor Quesada: To opine on this because when I read the minutes of their meeting, I think

they were unanimous in saying that money should be returned. And since they are our eyes and

ears when it comes to cultural events and activities within the City, you know, I rely on them --

we all rely on them almost implicitly on everything that they recommend. So, if I could just hear

from the board. Did an event actually take place?

Geannina Burgos: Good morning.

Vice Mayor Quesada: Morning.

Ms. Burgos: Geannina Burgos, with the Board. An event, from my understanding, recently took

place this past week, but it had not taken place at the time of all of those board meetings and

when this was written and presented before the Board.

Mayor Cason: Was that plan...

request was made. It's outside of that fiscal year. The Board granted an extension through

October of that year, and the performance just took place this past week.

Vice Mayor Quesada: So, was this -- do you think that this event was put on sort of hastily

rushed before this...

Ms. Burgos: I cannot speak for the organization on that.

Ms. Couty: Oh, that's -- sorry, but that is why I was here to explain why that happened.

Vice Mayor Quesada: Okay.

Ms. Couty: The grant writer -- apparently, there was a lot of miscommunication and, again, as I

mentioned with the center and there was a lot of change over as far as -- there was very few

personnel, which is why I stepped back in because they really needed some help. And this was

an oversight. Mr. Peña has been receiving grants from everything from the State of Florida on

down and performing and putting on things. He also received the keys to the city for his work in

the arts. He's not someone who would have wanted to overlook something. This -- whatever

happened with Mr. Jimenez, who is the choreographer, who had, in fact, gone to Colombia -- his

father was dying -- and then the festival came up. I wasn't there for all of this, so I'm not totally

aware of everything, but I do know that this was a huge oversight, and it's not anything we

would ever, ever mean to do. So, we were trying -- as the funds had been allocated. They had

rehearsed the dancers, and then they couldn't perform because also the Coral Gables Music Club,

she was on maternity leave. She was pregnant during that time, so they wanted to extend it

again. So, I just wanted to -- we just really want to apologize. I mean, this is not something our

been on the dais, and I guess I've been on for about five years now and...

Ms. Couty: Yeah.

Ms. Couty: I know it's...

Vice Mayor Quesada: I guess there are a few questions that I still have, some documents I

would like to see.

Ms. Couty: Yeah.

Vice Mayor Quesada: So, this event that just took place a week ago, where did it take place,

how many people attended?

Ms. Couty: Yeah.

Vice Mayor Quesada: I would also like to see an accounting of the funds that were used, so any

expenses that were had, any payments that were made. I want to see it. I sort of want -- I want

the full picture...

Ms. Couty: Okay.

Vice Mayor Quesada: Before I make a determination. At least -- I can't speak for the rest of us,

but my concern is if all these things were happening -- I mean, when we give you this money,

you have a fiduciary duty to us and to the City and to the residents...

Vice Mayor Quesada: To make sure that it's carried out. If everything is sort of falling apart --

and we understand tough times. There are health issues. There are family matters. We

understand that, especially someone as you're holding up Mr. Peña to be. And I don't know him

personally and the name doesn't ring a bell, so I have no gauge for his credibility at this time.

But when you tell us things like that, things happen. So, what should have happened is when

you asked for the extension, say, look, we'll do the extension, and if we can't, we'll return the

monies. That's, in my opinion, the way it should play out, not you know something, we're just

going to continue holding on to it and wait until something happens, and then a month after the

Cultural Board says return the money, put an event together, rush to say that you actually did

something. So, that's my concern about the whole thing because those \$2,500 are supposed to

go to the event.

Ms. Couty: Yes, I know.

Vice Mayor Quesada: That money comes from the residents.

Ms. Couty: I'm aware, sir.

Vice Mayor Quesada: You know, we have a duty and obviously, our residents enjoy the cultural

events, one of the great things about being a part of the community of Coral Gables.

Ms. Couty: Yeah.

Vice Mayor Quesada: So, I have a lot of concerns with it. That's why I want to see more

documentation related to this, which I don't know if you can provide now or not. But, it's just...

Ms. Couty: Right this minute all I have is the flyer.

Vice Mayor Quesada: About being forward thinking, and you know something, it happens to all

of us. Something goes awry, you know something, give the money back or say, hey, you know,

we're going to need a whole nother year. You asked for a shorter extension so...

Ms. Couty: Unfortunately, the grant -- there was a miscommunication with the grant writer. She

left, so we had -- I didn't -- and I -- personally, I was brought into this later on.

Vice Mayor Quesada: I know you weren't there, but you're here representing the organization...

Ms. Couty: But I do know -- yes.

Vice Mayor Quesada: So I have to ask you these questions.

Ms. Couty: But what I'd like to say is I can get more document -- all I did was print out the flyer

and a picture quickly, but I'd be happy to provide all the documentation if I can...

Commissioner Slesnick: Just to be clear, though. The grant was for the 2014-2015 cultural year,

and then an event never occurred. And they granted an extension through October. So, now

here we are in...

Ms. Couty: 2016, so 2015-16, they're trying...

Commissioner Slesnick: 2016 in May. I mean, there's a whole nother -- I mean, these grants --

there are so many organizations in Coral Gables that seek these grants. And by giving it to one

organization and they're not using it, it prevents other seed groups and so forth...

Ms. Couty: Right.

Commissioner Slesnick: To perform. So, you had a year and a half, and now six months after

that, somebody just had an event because you have other grants and funding from other

organizations. It just seems unfair to me to all the grants -- all the recipients that did apply for

this and receive it, used it within their calendar year. Now, we're now...

Vice Mayor Quesada: And the ones that applied and didn't get it, you know.

Commissioner Slesnick: Yes, because we had two or three that were right on the borderline that

didn't receive funding. So, I'm just saying I think you should have returned the money and then

gone ahead and applied this year, but it sounds like you weren't -- nobody was even organizing

to...

Ms. Couty: It was a miscommunication...

Commissioner Slesnick: But that's not the City's fault. That's not the taxpayer's fault.

Ms. Couty: No, I know.

Commissioner Slesnick: It's not the other recipients fault. It's -- you know, if you're just not

organized and can't do it, the funding should be returned.

Ms. Couty: Well, Mr. Peña also regrets that he couldn't be here. He is rehearsing for the Cuban

Classical Ballet performance. It's in two weeks, Gisele. But he would respectfully request if we

could -- he wanted to know if it could have been put for the 15-16 and we can -- because we are

trying to fulfill this obligation and that apparently was...

Vice Mayor Quesada: Typically -- the problem with that is -- although, yes, that is within our

purview to make that determination, we have the utmost respect and confidence in our Cultural

Board. And this comes to us on their, I think, unanimous recommendation...

Ms. Couty: Yes, which is -- I didn't have a have a chance to get all of that together.

Vice Mayor Quesada: I understand that.

Mayor Cason: And where was the event?

Ms. Couty: The event was at the Coral Gables Congressional Church.

Commissioner Slesnick: Congregational.

Mayor Cason: Congregational.

Commissioner Slesnick: Congregational Church.

Ms. Couty: The big, beautiful -- yeah. And it was a free event for the public. There were the

four dancers, a pianist...

Vice Mayor Quesada: Was notice given? How much notice was given for the event? Do you

know?

Ms. Couty: A couple of months.

Vice Mayor Quesada: A couple of months.

Ms. Couty: Yeah.

Commissioner Slesnick: And how many people attended?

Ms. Couty: That I'd have to -- I was not there personally.

Vice Mayor Quesada: Alright, so here's what I'm recommending...

Ms. Couty: So, I'd have to get the...

that you're stepping in on behalf of the people. It's really important that whatever information

may not be certain is accurate.

Vice Mayor Quesada: So, I have -- I sort of have my mind made up of what I want to do, but

I'm going to ask...

Ms. Couty: May I just mention...

Vice Mayor Quesada: Any representatives of the Board -- because look, my feeling right now is

to defer this item to the next hearing and to ask you to bring back -- I want proof that notice was

-- when the notice was first given for this event and who it went to and how it was transmitted.

Was it mail? Was it email? Was it a text message? Whatever it was.

Mayor Cason: And how many people attended.

Ms. Couty: Okay.

Vice Mayor Quesada: How many people attended, and I want an accounting of the funds that

were used for this event.

Ms. Couty: Okay.

Vice Mayor Quesada: I know it's out -- I just -- I want a full picture here. I want to know if this

was put -- because it sounds to me, based on the facts you're giving me and the facts as I know

them, that you guys saw this recommendation come down and then you rushed to put together an

event so that there was a (INAUDIBLE)...

sooner, I was going to present it at the April meeting, and then I was sick and I did email and let

them know what I was going to present in the March meeting when -- on April 4.

Mayor Cason: Dona.

Historic Preservation Officer Spain: I would like Catherine Cathers, Arts & Culture Specialist

for the City, to speak to this issue.

Arts and Culture Specialist Cathers: Good morning, Mayor and Commissioners. First of all, I'd

like to say we're absolutely so thrilled that the Cuban Classical Ballet has chosen Coral Gables to

start doing performances here. We're very happy about that and happy that you've done that and

are continuing to plan to do that.

Ms. Couty: Yes. We have more.

Arts and Culture Specialist Cathers: The reason that this came before the Cultural Development

Board was because the request for the extension came the day after the end of the fiscal year, so

that was our first, you know, red flag. And I have to say that -- and the Cultural Development

Board is always very recipient to requests for modifications, date changes, et cetera. The request

that we received for the delay after the end of the fiscal year was that they were unable to come

to an agreement with their venue. That was the reason that we were given. So, the Board said --

and the Cuban Classical Ballet said that they could do a performance within the next month, so

that's why we asked a representative of the Board to come and speak on their behalf. They did

agree to that, and then we didn't hear anything from them whether that had occurred or not. So,

as staff, we followed up, and at the Board's request for a follow up, so that we had still not

received a response and then we moved forward again to where we are today, so that is -- that's

why we're here from the staff's perspective and why we've asked a representative of the Board

to speak for the Board.

Ms. Burgos: Yes, thank you. So, the Board's reasoning behind this is that when it -- we're

fiduciaries, as well, and it is not fiscally prudent to set this precedent, even though things do

happen. Likewise, there are other organizations that have complied and we actually have given

extensions in the past to other organizations to comply within the fiscal year. We don't believe it

sends the right message, especially if we are trying to have organizations come in here and do

great work, which Pedro Pablo Peña is obviously a very well-known person in the dance

community, but is also not -- they're not new to granting, so this is not something that they

would be unaware of to comply with, a simple grant-making process that the City requires from

the grantees. Thank you.

Mayor Cason: You want to make a motion?

Commissioner Slesnick: I just feel that our City volunteers, our community volunteers,

residents, that sit on the Cultural Affairs Board spend so much time going through all the grants

and so forth and awarding these on how they perceive this affects the community and give the

grants dollars to go the furthest for the amount of people that attend. So, to have this from 2014

to 2015 and now coming up where they could have even applied again in October, but they

didn't respond to any messages and they didn't even get to you until after the fiscal year was

over, I just find it's -- I don't want to set a precedent because I served on the Cultural Affairs

Board years ago, that they work so hard that we shouldn't just give money to people that aren't

organized and don't have their act together because other recipients in the community should be

getting it so that money should be disbursed, and we did that. And I don't like to go over our

Commissioner Keon: Can I ask one question also? Yeah, you sound like you had some real

organizational and managerial problems with your entire -- with your organization for some

period of time here. Are you fiscally -- how is your organization fiscally? I mean, can you...

Ms. Couty: Oh, I do not want to...

Commissioner Keon: Return the...

Ms. Couty: Present a picture like that.

Commissioner Keon: I mean, can you return -- do you have the ability to return the grant funds?

Ms. Couty: That's not my department. I don't know anything about the -- as far as their money.

All I do know is that we do receive funds. We have the Miami Hispanic Cultural Arts Center

now that Mr. Peña had obtained with a grant. We're producing the Cuban Classical Ballet, the

International Ballet Festival.

Commissioner Keon: Right.

Ms. Couty: It was just -- somehow it was a miscommunication. The grant writer left. There

was just a miscommunication there, and this is unusual for us because...

Ms. Couty: I mean, we've been doing this for -- Mr. Peña's been doing this...

Commissioner Keon: As Commissioner Quesada has said, you know, due to the fact that it was,

you know, an oversight, you just -- you weren't able to comply, whatever, that, you know, if

what Commissioner Quesada is asking is that it be returned, I would certainly support, you

know, his request.

Vice Mayor Quesada: Well, here's what I want to do, okay. So, some facts have come out that

I'm unaware of, so I think it shows the credibility a little bit better. And I heard it from our side

of the table here is that Mr. Peña's been around a long time and this is an organization that has

been around a long time and they do some good work is what I'm anticipating. I would like to

defer this to the next meeting, but I want to be very specific and I ask that you write this down

either now or I can repeat it to you after.

Ms. Couty: Okay.

Vice Mayor Quesada: I want to see when that notice for this event in May first went out, okay. I

want to know how many people were there.

Ms. Couty: Okay.

last minute -- I hate the chronology of this. I mean, the chronology of this, it really bothers me

because it looks to me, on the facts that have been given to us now, that the moment they entered

this recommendation for you to return the funds, that you guys ran and put together an event.

Now, that's what it looks like to me, but you can disprove that by showing me documentation or

showing us documentation...

Ms. Couty: Yes.

Vice Mayor Quesada: That that wasn't the case.

Ms. Couty: Yes, I understand.

Vice Mayor Quesada: So, if you can please provide that proof to us so we can see that -- I will

tell you, even if -- at least my vote, I don't know if the rest of the Commission will be -- is to not

have you return those funds, you know, because the way this has played out, you know, I'm

going to say that you guys are not entitled to receive a grant from us for the next X amount of

years or something for a future discussion because the way this was handled...

Ms. Couty: Yeah.

Vice Mayor Quesada: Is very problematic for me. You know, we have a lot of cultural

organizations that are lobbying us all the time...

Ms. Couty: Yes.

and it was not spent and you guys didn't -- you didn't work with us. And I think what I heard

from the Board is we're very easy to work with; just keep us in the loop. And the fact that -- I

know you weren't there...

Ms. Couty: Yeah.

Vice Mayor Quesada: But you're the representative, so you have to hear this. That's very

problematic for us because what's the first thing that we're going to think when you don't

respond and we don't hear anything? Oh, they stole the money. That's the first impression. It

has to be the first impression, and that's the way we have to think. So, my motion's going to be

to defer it and they're required to bring that documentation or provide the documentation to the

Vice Mayor Quesada: So that we could see it.

Historic Preservation Officer Spain: Could I just add -- it's really more than just having an event

haven't seen this flyer, but there are other requirements of the grants that the other organizations

-- I mean, this is not a lot of money and it's a crazy amount of work for the organizations to do
