A RESOLUTION ACCEPTING THE RECOMMENDATION OF THE PROCUREMENT OFFICER TO AWARD THE KERDYK TENNIS CENTER BUILDING RENOVATIONS TO AZULEJO, INC., THE LOWEST RESPONSIVE AND RESPONSIBLE BIDDER, IN THE AMOUNT OF \$1,215,228.00, PURSUANT TO INVITATION FOR BIDS (IFB) 2017.12.VF AND SECTION 2-763 OF THE PROCUREMENT CODE ENTITLED "CONTRACT AWARD".

WHEREAS, on December 8, 2017, the Procurement Division of Finance formally advertised, issued and distributed the IFB for the Kerdyk Tennis Center Building Renovations; and

WHEREAS, on December 20, 2017, a non-mandatory pre-bid conference was held with eleven (11) prospective bidders in attendance of the sixty-six (66) prospective bidders who downloaded the IFB package from Public Purchase, the City's web based e-Procurement service; and

WHEREAS, on January 24, 2018, six (6) bids were received in response to the IFB 2017.12.VF from: Allied Contractors, Inc.; Azulejo, Inc.; Builcore, Inc.; E.L.C.O. Construction Group, Inc.; State Contracting & Engineering Corp.; and West Construction, Inc.; and

WHEREAS, the Public Works Department concurs with the Procurement Officer's recommendation to award the Kerdyk Tennis Center Building Renovations contract to Azulejo, Inc. in the amount of \$1,215,228.00; and

WHEREAS, Section 2-585 of the Procurement Code authorizes the City Manager to delegate authority to the Procurement Officer to administer and make recommendations on City contracts.

NOW THEREFORE BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

- **Section 1.** The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.
- **Section 2.** That the City Commission accepts the recommendation of the Procurement Officer to award the Kerdyk Tennis Center Building Renovations contract to Azulejo, Inc., the lowest responsive and responsible bidder, in the amount of \$1,215,228.00, pursuant to Section 2-763 of the Procurement Code entitled "Contract Award" and Invitation For Bids (IFB) 2017.12.VF.
