On behalf of Terrace Mountain Investors IV, LLC, (the "Applicant"), which is the owner of the 43,495 square-foot property consisting of Lots 22 through 38 of Block 2 of Revised Plat of Coral Gables Industrial Section, as recorded in Plat Book 28, Page 22 of the Public Records of Miami-Dade County (the "Property"), we hereby request permission to encroach into the abutting right-of-way of Altara Avenue, Laguna Street, and the public Alley of Block 2 for the installation sidewalks, curbing, asphalt paving, structural soil, landscaping, irrigation, public lighting, and underground utilities.
