RESOLUTION NO. 2018-21

A RESOLUTION OF THE CITY COMMISSION OF CORAL GABLES, FLORIDA DIRECTING STAFF TO PROCEED WITH THE STUDY AND PLANNING OF CITY BIKE PATHS, EXCLUDING THAT PORTION OF RIVIERA DRIVE LOCATED SOUTH OF US1, AND TO ADDRESS PARKING CONCERNS CREATED BY BIKE PATHS IN DOWNTOWN.

WHEREAS, the City desires to create bike paths throughout the City to encourage the use of bicycles and alleviate vehicular traffic; and

WHEREAS, the City, in furtherance of the desire to create bike paths, began a process to plan for bike paths in 2013 and hired private consultants to develop a bike master plan which was presented to the City Commission in 2014; and

WHEREAS, the City values the opinions of its residents and seeks opportunities to learn of and address resident concerns; and

WHEREAS, the City has received feedback from residents and business owners on the proposed plan and desires to address the concerns of residents and business owners that may be directly affected by the proposed bike paths throughout the City; and

WHEREAS, the City desires to continue with the study and planning of bike paths throughout the City while eliminating that portion of Riviera Drive, located in Coral Gables, south of US-1, from future consideration of a new bike path;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are made a specific part of the Resolution upon adoption hereof.

SECTION 2. That the City Commission does hereby direct the staff to proceed with the planning and studying of bike paths in the City, excluding that portion of Riviera Drive located south of US-1, and to address parking concerns created by bike paths in the Coral Gables downtown area.

SECTION 3. That this Resolution shall become effective upon the date of its passage and adoption herein.
