DRAFT RESOLUTION

A RESOLUTION ACCEPTING THE RECOMMENDATION OF THE PROCUREMENT OFFICER TO AUTHORIZE A COOPERATIVE CONTRACT WITH GENUINE PARTS COMPANY D/B/A NAPA AUTO PARTS FROM THE NATIONAL JOINT POWERS ALLIANCE (NJPA) TO PROVIDE ON-SITE VEHICLE AND EQUIPMENT PARTS AND SUPPLY SERVICES PURSUANT TO SECTION 2-947 OF THE PROCUREMENT CODE.

WHEREAS, the City's on-site vehicle and equipment parts and supply services are provided by Genuine Parts Company d/b/a NAPA Auto Parts; and

WHEREAS, Procurement is recommending utilizing the cooperative agreement through the National Joint Powers Alliance (NJPA) under Section 2-947 of the Procurement Code; and

WHEREAS, NJPA is a public purchasing cooperative set-up by the State of Minnesota with over 50,000 member agencies nationwide, which the City of Coral Gables is also a member; and

WHEREAS, the current NJPA contract with NAPA was competitively solicited by the National Joint Power Alliance under RFP No. 061015 which complies with the solicitation requirements contained within Section 2-945 of the Procurement Code; and

WHEREAS the Procurement Officer is recommending the utilization of this contract and subsequently awarded NJPA contracts with Genuine Parts Company d/b/a NAPA Auto Parts; and

WHEREAS, under Section 2-947, the City may participate in cooperative purchasing agreements for the procurement of any goods or services with one or more governmental units in accordance with an agreement entered into between the participants.

NOW THEREFORE BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

Section 1. The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

Section 2. That the City Commission does hereby accept the recommendation of the Procurement Officer to authorize a Cooperative contract with Genuine Parts Company d/b/a NAPA Auto Parts from the National Joint Powers Alliance (NJPA) to provide onsite vehicle and equipment parts and supply services pursuant to Section 2-947 of the Procurement Code.

Section 3. That this Resolution shall become effective upon the date of its adoption herein.
