

# City of Coral Gables CITY COMMISSION MEETING August 28, 2018

## **ITEM TITLE:**

A discussion regarding sale of Lot 24 to Doctors Hospital originally proposed in Resolution 2017-212. (*Sponsored by Mayor Valdes-Fauli*).

### **DEPARTMENT HEAD RECOMMENDATION:**

Approval

#### **BRIEF HISTORY:**

Per Resolution 2017-212, a Letter of Intent ("LOI") was presented to the City Commission relating to the Doctors Hospital (the "Hospital") potential purchase of parking Lot 24 (the "Lot") for \$3,000,000 (See attached Letter of Intent). At that meeting, the City Commission directed staff to renegotiate a longer term lease vs. a sale to the Hospital (e.g., a 99-year lease).

During those discussions, the Hospital stated they have no desire to enter into an extended lease. After those discussions and per Resolution 2017-298, the potential sale was rejected with a 3/5<sup>th</sup> City Commission vote. Per Resolution 2017-299, the City Commission instructed City Staff to continue negotiations for a 99-year lease. After Staff revisited negotiations, the Hospital maintained their only desire is to purchase the Lot and does not have an interest in a new or amended lease (existing Lease expires December 30, 2048). Per Enactment 2018-23, on January 23, 2018, the Commission discussed the sale and then deferred the item.

The City is asking to proceed with negotiating a purchase and sales contract based on the proposed price of \$3,000,000 and return to the Commission with a proposed purchase and sales agreement.
