Remedy by: Comply with section 5-1803 of the City Code. City Code - Chapter 34, section 34-165. Failure to register abandoned real property on an annual basis.

Code Enforcement Officer Comments: Fallen leaves and dead vegetation on the roof, property is not registered, walkway and chimney are dirty and plant containers etc. are on the porch and in the rear vard.
