Analysis:

Termites have gain access to the entire building through:

- termite activity was found in and around stairs, community walls, and community trim
- termites fly into the building, but could also come from the ground up
- exterior and interior wood doors may be a beginning for termite infestations
- flooring where not in the best condition and did showed signs of termite damage
- entire building could be vulnerable to subterranean termites just as much as drywood termites

Solution:

My professional recommendation is that the structure needs to be treated with liquid termiticide products:

- all baseboards and cracks around baseboards will be sprayed when possible in communal areas
- wood exterior door frames injected if possible around exterior of building and interior communal areas
- trench around the exterior perimeter only will be dug and liquid termiticide product will be applied for Subterranean Termite Protection and/or Control
- all interior doors in communal area will be injected with foam to protect the interior voids of the doors in all units
- each unit attic will be mist to coat all exposed wood with termiticide product for termite prevention
- the exterior of the soffit areas will also be treated to prevent termites from laying there and create new nests
- all visible termite colonies in the communal areas will be injected
- crawl space will be treated with same technology as the attic to coat exposed wood and to prevent termite activity

Note: liquid could be done ASAP with minimal preparation, also liquid will prevent new coming infestations since this is Termite season. Home occupants could stay at their units while the treatment takes place.

There is some termite damage hidden and some visible. We can not be responsible or liable for any of the termite damage.

Termite damage at this point could be observed in subflooring, walls, trim, and windows of communal areas.

Monitoring

Reduction & control of existing unknow termite populations or new infestations can be achieved by:

- inspection and warranty renewal of interior and exterior once per year
- liquid reapplication every 5-7 years
- more than likely all termite activity will be eliminated within 60 days of application

All services come with one year warranty and then could be renewed yearly.

ESTIMATE

Green Palm Pest Control can perform the above described work as follows:

- Preventive Liquid Termite Treatment: \$2,800.00
- Multiple unit discount of \$1000.00
- The renewal price will be \$265.00 per year and could be paid in advance for 1 or 2 years
- Total Price for Complete Corrective Termite Treatment and 12 months warranty: \$1,800.00
