## **RESOLUTION NO. 2018-139**

A RESOLUTION ACCEPTING THE RECOMMENDATION OF THE PROCUREMENT OFFICER TO EXTEND THE DEBRIS MANAGEMENT SERVICES CONTRACT WITH ASHBRITT, INC., (PRIMARY) AND CERES ENVIRONMENTAL SERVICES, INC., (SECONDARY) PURSUANT TO SECTION 2-764 OF THE PROCUREMENT CODE ENTITLED "APPROVAL OF CHANGE ORDERS AND CONTRACT MODIFICATIONS", ON A MONTH-TO-MONTH BASIS, NOT TO EXCEED SIX MONTHS, UNTIL THE NEW RFP PROCESS IS COMPLETED, AND NEW PROFESSIONAL SERVICES AGREEMENTS ARE AWARDED, NEGOTIATED AND EXECUTED.

WHEREAS, on March 10, 2009, the City Commission approved Professional Services Agreements ("Agreements") for Debris Management Services as the result of Request for Proposals (RFP) 2008.05.05; and

WHEREAS, the purpose of the Agreements are to obtain Debris Management Services in accordance with Federal Emergency Management Agency (FEMA) policies, procedures, and directives; Federal law, regulations, and executive orders; and State / Local law and regulations; and

WHEREAS, the current Agreements with AshBritt, Inc., (Primary) and Ceres Environmental Services, Inc., (Secondary) expire on June 1, 2018; and

WHEREAS, in order to allow time for a new RFP process to be completed and new contracts negotiated and executed, it is recommended that the Debris Management Services contracts be extended on a month-to-month basis, not to exceed six months, until the new RFP process is completed, and new Agreements are awarded, negotiated and executed; and

WHEREAS, Section 2-585 of the Procurement Code authorizes the City Manager to delegate authority to the Procurement Officer to administer and make recommendations on City contracts; and

WHEREAS, the contracts with AshBritt, Inc., (Primary) and Ceres Environmental Services, Inc., (Secondary) may be extended under Section 2-764 of the Procurement Code entitled "Approval of Change Orders and Contract Modifications";

## NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

**SECTION 1.** The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

**SECTION 2.** That the City Commission accept the recommendation of the Procurement Officer to extend the Debris Management Services contract with AshBritt, Inc., (Primary) and Ceres Environmental Services, Inc., (Secondary). pursuant to Section 2-764 of the Procurement Code entitled "Approval of Change Orders and Contract Modifications", on a month-to-month basis, not to exceed six months, until the new RFP process is completed, and new Professional Services Agreements are awarded, negotiated and executed.

**SECTION 3.** That the City Commission does hereby authorize the City Manager to execute an extension of the Contract with such modifications to the form attached hereto as Exhibit "A" as may be approved by the City Manager and City Attorney that are necessary to implement the intent of this Resolution.

**SECTION 4.** That this Resolution shall become effective upon the date of its passage and adoption herein.
