City Manager Iglesias: Mr. Mayor this is for Plaza at Lot 25, the checkered concrete and we are providing...conditions similar to Giralda for the new art installation.

Commissioner Keon: I'll move it.

City Manager Iglesias: I believe that Dona can speak concerning that. The issue was using the same craftsman that installed the 316,000 pavers on Giralda and before left to do that installation after...If we didn't do it now we might get some other styles that would not provide the quality and could be a higher price.

Historic Preservation Officer Spain: If you are on the east end of the Giralda Plaza there was a fairly unattractive plaza that always had mud in it because it drained. The pavers were not part of the original scope of the Giralda Plaza, but its where the artwork, the large marble structures that were approved a few years ago, where its scheduled to be installed. There are three going in that plaza and one at the west end near Ponce, and so, this just continues the paver into that area which is an appropriate thing to do.

City Manager Iglesias: You've also...the area and provides additional drainage that they did not have, there was continuous flooding, and Giralda doesn't look finished leaving it there.
