There have been no changes between first and second.

Vice Mayor Lago: Well, Mayor, if I may. In regards to F-1, I don't know if we want to have the attorney representing the applicant. I have an item -- I have a potential change which I...

Mayor Valdes-Fauli: This is on second reading, right?

Vice Mayor Lago: Yes. I have a potential change I would hope you would approve. Do you have the exact section in reference to the development agreement?

City Attorney Ramos: The Deputy City Attorney is on her way down and she can read it into the record.

Vice Mayor Lago: Okay. To make a long story short, it's very simple. There's a portion that states that \$2.7 million would either be used for police or some sort of...

Mario Garcia-Serra: Public safety.

Vice Mayor Lago: Public safety need or art. Like I mentioned to you before, I think this is a once in a lifetime opportunity to really deliver on a world-class art which would draw people to the community. I think we should spend that money -- I've talked to the Manager and we can find other ways if there is a gap that we were proposing to use that money for. I think there's other

opportunities or revenue streams that we could make it up to basically fit the need of whatever it is that we need for public safety.

Mayor Valdes-Fauli: I fully agree with you.

Vice Mayor Lago: And I think what we need to do is dedicate this money wholeheartedly so that we can have the necessary art budget so that they can deliver on potentially probably one of the biggest draws in Miami-Dade County for Art in Public Places.

Mayor Valdes-Fauli: I fully agree with you and support that.

Commissioner Mena: My only question is -- because generally, I agree with you. My concern is it's my understanding that 2.7 has basically been budgeted for the Public Safety building. It's not that it was like a we might tap into it, we might not. It is part of the funds allocated towards the Public Safety building right now. So, you basically would be putting a \$2.7 million hole in the budget for that building that we'd have to come up with funds to bridge that gap. So, that's my concern.

Vice Mayor Lago: I know.

Commissioner Mena: If this was just money that we could make a choice of A or B...

Vice Mayor Lago: It's a very valid concern.

Commissioner Mena: Yeah.

Vice Mayor Lago: What I asked you -- I mean, and I don't know if the Manager wants to discuss the option that we have on the table, which...

City Manager Iglesias: Well, I think that we have something else now that we have the potential sale of the General's house, which is on Granada, the 30th block of Granada. So, I feel if we sell that, maybe we -- if we have the ability of selling that, using it for the Public Safety building. And in addition, looking at what impact fees for fire -- police and fire come in because the completion of the building will be in August/September of 2020, and we may be able to make this up based on that. So, it would be good if we have the ability to -- the general has moved out. They're exercising the 90-day clause. The general would prefer to live in Doral because of the commute. And so, if we have that ability, then I think maybe we can make up for this \$2.7 million.

Commissioner Mena: My only question there would be, do you need the full 2.7? Is there a way to like...

Vice Mayor Lago: I'd like to have all of the 2.7.

Commissioner Mena: No, I know, but like how much -- like if we have a rough idea...

Vice Mayor Lago: We have about a \$700,000 gap, correct me, if I'm wrong, in reference to -- and one of the things that maybe -- this is -- I'm speaking and I shouldn't be speaking. I'm being out of turn, but I'll let Ed Santamaria, Assistant City Manager -- because he mentioned in the meeting that not only is it -- I want to sell the house because I want to use those funds for art, and I want to make sure we can get the funds that we need, obviously, for the Public Safety building. He said it was also -- and I -- you know, I hate to -- it was a little bit of a nightmare in reference to the maintenance over the last few years...

Commissioner Mena: The house.

Vice Mayor Lago: Of the house. So, the house needs some updating, and again, if we sell the house, we'd probably -- due to the location and the market right now, I think we'd have a good windfall right now.

I would not like that and I'd like to find a way that we can do that, but I want to make sure that we at least allocate the \$2 million.

Mayor Valdes-Fauli: And we will find a way to...

We're making a significant investment in our community and I don't want to leave our Manager, you know, in a shortfall.

Deputy City Attorney Suárez: So, the language is not changed by this amendment. It currently states that the allocation of the contribution is in the sole discretion of the City Commission for either of the following two purposes: public safety -- all or part of the contribution may be used for the public safety needs. And then B is public art. All or part of the contributions may be used for the installation of publicly-accessible artwork into the project or in Ponce Circle Park, adjacent to the project, or in both places, for the benefit of the project and of the City. And it describes the kind of artwork and it says that the City Manager will inform the owner of and give the owner opportunity to comment on the identity of the artist and the specific works of art the City intends to purchase using this additional contribution. The exact placement of art purchased with this additional contribution shall be determined by the City Manager after providing the owner an opportunity to comment on the proposed location. So, you may want to -- I think there was an understanding that it would come back to Commission.

Vice Mayor Lago: Yes.

Deputy City Attorney Suárez: So, you may want to add language that any artwork...

City Manager Iglesias: We are ballparking between 1.6 and \$2 million and something, 1.7 or \$2 million, something in that neighborhood.

Mayor Valdes-Fauli: We acquired this house in 1999, and there was a big fight with the Commission because, you know, we weren't in the business of buying a house and we did it out of public service to try to make it easier for Southern Command to stay in Miami-Dade County. They were thinking of moving elsewhere and this commanding officer, the commanding general or admiral, had had to move three or four times, from one house to the other and we bought this to make it accessible to them. And they were very, very appreciative and it worked. They stayed here.

City Attorney Ramos: Mr. Manager, I would suggest a separate resolution regarding placing the house for sale, separate from the development agreement.

Mayor Valdes-Fauli: Okay.

Vice Mayor Lago: Before I move forward -- and if I may, Mayor, just for a second. I want to make sure -- Commissioner Mena had a comment at the end. He's trying to obviously do the math in his head to see where the delta is. I'm just trying to make sure you're comfortable. If you're not comfortable with this...

Commissioner Mena: No. I just think, to me, if I have to prioritize the two things, I'd have to prioritize the Public Safety building over the piece of art, as much as I would -- as much as you would love...

Deputy City Attorney Suárez: Contribution in addition to the requirements.

Commissioner Keon: So, there's going to be artwork -- they are -- they have -- it's my understanding from what we saw at one point in the discussions with them that they have a considerable plan for artwork on the site. Is that right? So, this is like...

Unidentified Speaker: Mr. Mayor, if I...

Commissioner Keon: Just, you know -- I mean, it's -- they are meeting all of the requirements for public art on their site through the development agreement already. This is just extra.

Mayor Valdes-Fauli: Yes.

Commissioner Keon: So...

Mayor Valdes-Fauli: Commissioner, let...

Mr. Garcia-Serra: Sure. If I may, Mr. Mayor. Mario Garcia-Serra, with offices at 600 Brickell Avenue, representing Agave Ponce LLC, the owner and developer of the project. How we look at this, overall, our preference is, of course, to -- for the money, as much of it as possible, to go to the public art because we see greater benefit coming from that. To sort of give you a summary, the base Art in Public Places obligation is already met, a different paragraph of the development

agreement. It's around a \$4 million amount that's already going into the actual project. This 2.7 is in addition, and right now, it reads either art or public safety. What I'm understanding here from the Commission is that, if it's possible, I think what the intent is, let's try to dedicate it to art, but we have other needs and other requirements. If necessary, we might need to dip into that money to be used for public safety. And I think right now the language that we have is pretty good. I think we could maybe incorporate some more in there the sort of idea that the preference is to try to use as much as possible for the art.

Mayor Valdes-Fauli: Right.

Commissioner Mena: That's fine.

Vice Mayor Lago: Right. That's what I was saying. So -- and the -- Commissioner Keon mentioned the issue of the budget for the public safety, but there is already a budget and I've gone over the budget with the Manager. We have a GMP in place already with the contractor. It's \$53 million plus a contingency on it. So, the budget's already placed. The amount of money -- but this money was never -- when this agreement was drafted and agreed upon between the applicant and the City, there was no discussion of the Public Safety building.

Mr. Garcia-Serra: No. It was talking about operations.

Vice Mayor Lago: But there was a discussion of potential -- very broad public safety, which is perfectly fine with me. And I agree with Commissioner Keon and Commissioner Mena. We should make sure that we don't take money away from the Public Safety building. Let's find another round, another avenue. Let's try to -- let's see what we can do. If we have this house here that's available and we're not going to -- we're not in the -- like our -- Ed Santamaria mentioned to me in the meeting, he goes, listen, the house needs a lot of work. It's been a maintenance issue for a long time. You know, again, when you talk about open space, when you talk about commercial property and you talk about historic property, I'm not in the business of selling. Look,

we have one residential property in the City. You know, I'll sell it to be able to fund the Public Safety building, that portion, that delta that's missing, along with adding -- I trust the developer in bringing world-class art. I've seen what they have and I think the City would benefit greatly. And if any of you attended this weekend's Art Basel event and what this staff did, it was world class. I got dozens of emails and text messages from people asking me, you know, about what this City was able to do and how this is the third year that we do a sanctioned Art Basel event. The amount of people that attended it, people from outside the City, they came all the way down from West Palm Beach. People who I met -- it's -- I want to be the hub for art. And I think that that hub for art will pay dividends across the entire city.

Mr. Garcia-Serra: And this project could potentially be the epicenter of that.

Mayor Valdes-Fauli: Let's -- the motion has been made and seconded. Let's go on. We're all in agreement.

I mean, they're bringing art that's in major museums and collections all over the world.

Mr. Garcia-Serra: We're hoping to make this project and the area around there really the epicenter of art here in Coral Gables. And in order to get that done, we need the money in order to do it which we've committed, of course, already from our own pocket. So, that is -- you know, that's the task at hand and that's why we have that preference for the artwork and indeed, work has started with programming.

Vice Mayor Lago: Dona, what do you think? Talk to me.

Historic Preservation Officer Spain: Well, I'm for the art.
