Mayor Valdes-Fauli: D-10 is a Resolution of the City Commission of Coral Gables authorizing the donation of a gently used play structure, previously located at the War Memorial Youth Center to Santa Tecla La Libertad, El Salvador, our newest Sister City. When I took it around our City, the Youth Center, they were very, very impressed because they are trying to combat the Moras to combat the juvenile grounds, they have established great programs in education, entertainment, etc., for our little kids and not so little kids, and this would be a great donation for us to them to help them in that effort to combat juvenile delinquency, juvenile crime. I'll ask our City Manager why we have to get rid of this, he said that we have to modernize it, it was used, and we went out buying a new, different play structure, so this was totally superfluous and the money in the Sister City Foundation is being used to transport it so there won't be no expenditure of City funds. I think it's a wonderful thing we can do to combat juvenile crime and for our Sister City and I would like to have that approved separately, if possible.

that right? - Isn't it USO that covers the cost of moving this and taking this to...?

Mayor Valdes-Fauli: Would you like to address that? We have the Chair of the International

Affairs Coordinating Council here; would you like to address that?

Ms. Lourdes Cuzan: Happy New Year to all of you. Commissioner Keon, Mr. Rafael Gavarette

here, he is our liaison to, I'm sorry, he has helped us in the past with donations and transportation of equipment to other of our Sister Cities and so he has taken on the responsibility of getting

quotes for the transportation of the equipment and so forth. What specifically did you want to

know?

Commissioner Keon: What was my understanding then in the past when we have donated things

to other Sister Cities and I think it was in Antigua, I think we donated things, it was my

understanding to Parks that it was through, I'll ask the Manager.

City Manager Iglesias: USA.

Commissioner Keon: USA – that covered the cost of the transportation and whatever else, so it's

a nice donation for us and certainly is not a burden to do it.

Ms. Cuzan: The difference here is that those were considered humanitarian donations, whereas

this is not considered a humanitarian donation. So, there are certain restrictions as Mr. Gavarette will explain when there was a fire engine that was donated to Guatemala. So that was a very

different type of donation.

Mayor Valdes-Fauli: Commissioner there is a foundation that was established for these type of

things in the International Affairs Coordinating Council and Mayor Cason established it and

there would not be any City funds for this.

Commissioner Keon: Right.

Ms. Cuzan: So, there are no City funds involved with this transaction.

Vice Mayor Lago: But it's not USAID, so then it's this organization that was founded by Mayor

Cason that would provide the necessary funds to deliver this play structure.

Ms. Cuzan: That is correct.
