A RESOLUTION OF THE CITY COMMISSION AUTHORIZING MAKE-A-WISH SOUTHERN FLORIDA, TO SELL ALCOHOLIC BEVERAGES AT THE PARKING LOT LOCATED ON 1159 SUNSET DRIVE AND SAN IGNACIO AVENUE FROM RED ROAD TO YUMURI STREET ON SATURDAY, MARCH 9, 2019, BEGINNING AT 12:00 NOON UNTIL 4:00 P.M., DURING THE "*WINGS FOR WISHES*" EVENT TO BENEFIT THE MAKE A WISH SOUTH FLORIDA; SUBJECT TO FLORIDA DEPARTMENT OF PROFESSIONAL REGULATION REQUIREMENTS.

BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. That the City Commission does hereby grant permission to Make a Wish Southern Florida to serve alcoholic beverages during the *"Wings for Wishes"* event and is in compliance with the laws of the State of Florida.

SECTION 2. That this event will take place at the parking lot located on 1159 Sunset Drive and northern adjacent street (San Ignacio) on Saturday, March 9, 2019, beginning at 12:00 noon until 4:00 p.m.. *"Wings For Wishes"* is a fun event hosted by Make-A-Wish Southern Florida by local professionals committed to making life better for children with life-threatening medical conditions. In its first two years, the event raised more than \$50,000 to grant wishes. The 2019 event will be larger and more vibrant than before. The event will take place behind Sports Grill South Miami and will be in a 'block party' format with a wing tasting component in addition to the crowd-favorite wing eating competition. Sports Grill will feature six different tasting stations, while patrons will be able to pair their food with a variety of different craft beers and/or wine. The afternoon will feature live music, a DJ, and plenty of fun events for kids and adults alike. 100% of the proceeds benefit Make-A-Wish Southern Florida.
