appropriate the Police and Fire funds to for the construction of the New Public Safety Building,

Finance Director Gomez: Good morning. In order to meet the funding needs of the construction

for the New Public Safety Building, staff is recommending utilizing Police and Fire impact fees,

\$711,006 from police impact fee balance -- fund balance and \$399,222 from the fire impact fee

balance. It's in the fund balance. It's been received. We just need authorization to transfer it

into -- so we can use it.

Mayor Valdes-Fauli: Do I hear a motion?

Finance Director Gomez: As well as -- I'm sorry. As well as a million dollars from the parks

impact fee to the Ponce Circle Park Project.

Mayor Valdes-Fauli: Do I hear a motion?

Vice Mayor Lago: No. We got to talk about that.

Mayor Valdes-Fauli: Okay.

Vice Mayor Lago: So, in reference to park impact fees, explain to me -- that was what we had

discussed before, that some of those funds wouldn't be used for renovation of parks, correct?

Finance Director Gomez: So -- right. So, parks impact fees -- so there are several projects that

are within -- that parks impact fees are being used for. Some -- I'm not sure what the question is.

Vice Mayor Lago: The question is those funds that we're discussing right now, the million

dollars that are impact fees being paid by developers.

Finance Director Gomez: Sure. We need to take a million dollars of it...

Vice Mayor Lago: Instead of allocating it for...

Mayor Valdes-Fauli: For a park.

Vice Mayor Lago: You know, for renovation of parks and...

Finance Director Gomez: But, we're allocating it to the Ponce Circle Park project.

Vice Mayor Lago: Well, I thought we already had monies already allocated for that.

Finance Director Gomez: So, we only have -- we currently have \$2 million for the Ponce Circle

Park project and it's anticipated that that project will be a larger project, so we are transferring a

million dollars from parks impact fee fund balance to fund that project.

Vice Mayor Lago: I don't know how comfortable I feel with spending that money on Ponce

Circle Park, which gets little use because of its location, in my opinion. I don't have any issues

with anything else that we're discussing today. But, I think that maybe those million dollars

should be used for what you discussed before, Commissioner Mena. Let's use those monies to

really finish off those parks that we...

Mayor Valdes-Fauli: Okay, but...

Vice Mayor Lago: May be short on. I'm just...

Mayor Valdes-Fauli: I disagree with that. This can be -- and with the Paseo project, this will be

the most important project in parks in the City of Coral Gables. And that park is not used, I fully

agree with you, because it is a horrible place. Let's make it into a better -- the center of the city,

the center of downtown is going to move south to that project and I would use it there as opposed

to ten little parks in other places. This is the center of -- it will be the center of our downtown.

And the park, I agree, again, it's not used because it is horrible with those horrible historic pine

trees. Let's use it for that and let's improve that and make it a usable space.

Finance Director Gomez: I would have to defer.

Commissioner Quesada: So...

Assistant City Manager Santamaria: So, there have been some preliminary discussions. There

was a design charrette that most of you...

Commissioner Quesada: Yeah.

Assistant City Manager Santamaria: Attended. And, what was discussed is around the

neighborhood of 3 to \$4 million. And so, what we have right now committed is \$2 million and

that comes from the developer. And, there are park impact fees that have been paid into the open

space fund that would add another million dollars to the project.

Mayor Valdes-Fauli: I went it Burgalicious there and Rotary is having a festival there. That

park will get an enormous use by people. It will be a community event, a citywide festival, and I

think that we should not take funds away from it.

Commissioner Quesada: Yeah, and...

Vice Mayor Lago: (INAUDIBLE)

Commissioner Quesada: I agree with the Mayor. You know, we've had designs and thoughts go

as far back as -- probably before then also, but the Neighborhood Renaissance, where there

downtown is going to shift a little bit south. I'd say the center point of our downtown is the

Houston's area. (INAUDIBLE) shift a little bit. You're going to have a lot of office space.

You're going to have a lot of residential. There'll be a lot of movement there.

Mayor Valdes-Fauli: (INAUDIBLE)

Commissioner Quesada: Yeah, and I think the Mayor's right. Any time you have a big event

that they promote just a little bit, you get a lot of people there. And with more people living in

the downtown, I think it's important that we have a great downtown park. You know, we had

talked about doing a small amphitheater. We talked about doing some more artwork in there.

Like as much money as we can set aside, you know, I'm in favor of. Remember, the Agave, also

they had given us designs and at one point, I even -- I think one of the biggest problems we have

at that park is access to it. Even though it's sort of in the middle of our downtown, it's sort of

hard with the...

Commissioner Quesada: Streets on both sides. But it's going to be a problem. The only way

it's going to get fixed is by -- is with money, I hate to say it. So, anything we can allocate to it,

I'm always going to be in favor for.

Vice Mayor Lago: I just -- let me add a point. I mean, when I wrote the legislation about park

impact fees to bring in the revenue and then we amended that as a result of Commissioner

Mena's comments about using some of those funds not only to acquire, but also to correct some

of the existing parks that we have in place that needed much needed TLC, I just want to make

sure that everybody here understands we're taking a million dollars from what we've supported

to basically correct a park that, in my understanding, we, at one point, had planned a fountain of

youth there and I don't know how many millions of dollars were expected to go -- that was

before my time. I walked into that one.

Commissioner Quesada: About \$5 million I believe the number was.

Vice Mayor Lago: About \$5 million. So, to me, now we're down to \$2 million. What are -- did

the City not have any funds allocated there or were those funds also diverted to some other

project? Because, I remember there was \$5 million that Commissioner Quesada just mentioned

right now.

Finance Director Gomez: In the Ponce Circle Park?

Vice Mayor Lago: Yes, ma'am.

Finance Director Gomez: So, I believe that quite some time ago, there was maybe \$4 million.

Some of that was -- had to do with the NRP dollars. It wasn't ready to be used. We had to spend

the NRP dollars, so it was reallocated for other projects -- parks projects or other projects that the

NRP was eligible to fund and then that project I think -- I want to say a couple of years ago it

was -- there was no funding in there. And then, with the Agave money, the \$2 million was put in

there for the Ponce Circle Park and now we're putting a million dollars in with (INAUDIBLE).

Mayor Valdes-Fauli: (INAUDIBLE) to the charrette or the presentation. I think Commissioner

Mena and I were the only ones there. And that is going to be a beautiful public space with room

for shows, with fountains, with playground for kids. It's going to be a beautiful place and it's --

today, it's a waste.

Vice Mayor Lago: So, is it -- but is that -- but I just want to make sure we're clear. So, those

million dollars, are they depleting what we have in the account right now?

Vice Mayor Lago: Depleting every last dollar from that?

Finance Director Gomez: So, the -- the park...

Vice Mayor Lago: (INAUDIBLE) that -- this is not what that legislation was written for. I just

want to be clear that that's not what we -- what I sponsored and what I worked on and I brought

before this Commission. We're taking that money and we're using it...

Finance Director Gomez: So, the parks impact fee...

Vice Mayor Lago: (INAUDIBLE) notified.

Commissioner Quesada: (INAUDIBLE) but what was the -- okay, that's a different...

Vice Mayor Lago: (INAUDIBLE)

Commissioner Quesada: That's a very important point I think you just mentioned.

Vice Mayor Lago: The intent was to inquire, and then Commissioner Mena brought up a very good point. I wish I had the minutes here. It was a very good point. I think we ended up negotiating like 15, 20, 25 percent of those monies that we collected as impact fees would go

towards a much, much (INAUDIBLE) look at the situation we're in right now. We've waited,

what, a year and a half for Betsy Adams Park to be actually completed. So, we said, that's a

great idea, Commissioner. Let's address it.

Commissioner Quesada: So...

Vice Mayor Lago: If that's what you want, if that's what we want as a Commission, then we'll

move forward. But, I just think that we're -- we put that mechanism in place (INAUDIBLE)...

Commissioner Quesada: (INAUDIBLE) consistent with what ordinance we created and the

Code that we created. So, is it inconsistent, this million dollars?

City Attorney Ramos: It's -- it was a preference.

Finance Director Gomez: Right. I don't know that there was anything that was...

City Attorney Ramos: (INAUDIBLE) resolution. I'm pulling it up right now. And it was for

park impact fee priority. And, what it says was to utilize park impact fees for park acquisition

unless such fees are otherwise earmarked for other park system improvements.

Commissioner Quesada: Okay, so...

City Attorney Ramos: It was just direction to staff. It was not an ordinance.

Finance Director Gomez: And so, some of the funding is being used towards the renovation of

the passive parks and other renovations of the newer parks. But in this case, it's going to be for

the renovation of the Ponce Circle Park, a million dollars of it.

Vice Mayor Lago: Yeah. That's not what -- because we actually put numbers...

colleagues (INAUDIBLE).

Mayor Valdes-Fauli: (INAUDIBLE)

Commissioner Quesada: See, I'm okay with...

Commissioner Mena: I second that.

Commissioner Quesada: I'm okay with -- yeah, I'm okay with it.

Mayor Valdes-Fauli: Alright. Will you call the roll on that, please?

City Clerk Urquia: Commissioner Mena?

Commissioner Mena: (INAUDIBLE)

Assistant City Manager Santamaria: I just want to put on the table here that that will impact the design schedule for the park and -- because we still have to determine scope and determining scope, there has to be a financial consideration to it. So, the sooner that we have a decision on this matter, the better it is...

Mayor Valdes-Fauli: Let's put it on the agenda for the next meeting. But, I think it's very important -- I'm all for neighborhood parks and I'm very proud that our goal is to have a park within a ten-minute walk of every resident. But, we also need a park where 5,000 people can meet.

Vice Mayor Lago: I agree.

Mayor Valdes-Fauli: Where 10,000 people can meet. Look at Burgerlicious. Look at Rotary's -- you know, the festival that's coming up. There are a lot of festivals and we need public spaces in Coral Gables. And, this would be a wonderful -- let's put it on the agenda for the next meeting.

-- and Commissioner Mena's mentioned before, there's a reason why I wrote this piece of

legislation because this is, again, I believe at the bedrock of what Coral Gables stands for, open

space. So, we need...

Mayor Valdes-Fauli: Open space including a big park, yes.

Vice Mayor Lago: Yes, open space including a big park. But, I want to make sure that after

we've had this impact fee in place and it's been rolling forward and projects have started and

they've paid their impact fees, I want to know how much money is currently in those impact fees

and I want to know what are we taking out from that, because I have a feeling you're taking a

pretty big chunk out of it.

Commissioner Keon: No. (INAUDIBLE)

Commissioner Mena: I think we need to understand...

Vice Mayor Lago: A million dollars is a pretty big chunk.

Commissioner Mena: On the legal side and based on what Miriam just read us, am I wrong that

the million would have to be within the 35 percent of the overall?

Vice Mayor Lago: Yep.

Finance Director Gomez: May I ask does that -- from that point forward or including the

balances that existed at that time that may have already been allocated. So, I'm not...

Commissioner Keon: But Diana, it's my understanding...

Commissioner Keon: I mean, I remember when you came to us on the Neighborhood

Renaissance Program. Because part of the requirements in the bonding was that the...

civic plaza, \$600,000. Leucadendra Passive Park, \$175,000.

Vice Mayor Lago: But let's go back.

Finance Director Gomez: Ponce Circle Park, \$1 million. And the Coral Gables High School

track lighting is \$300,000. That's about \$3.2 million and there's \$145,000 that's unallocated.

Vice Mayor Lago: So, what happened to...?

Finance Director Gomez: And then, (INAUDIBLE) remember that there's park mobility -- no,

park impact fees for the Underline that has -- because we also had to set aside...

for the renovation of existing parks, correct? The other remaining 65 percent was for acquisition
