#### **RESOLUTION NO. 2019-32**

A RESOLUTION RECOMMENDING APPROVAL OF ADDITIONAL DESIGN SERVICES TO AECOM TECHNICAL SERVICES, INC. IN THE AMOUNT OF \$290,000 FOR INCREASED SQUARE FOOTAGE, CONSTRUCTION COST, AND DESIGN SCHEDULE DURATION TO THE NEW PUBLIC SAFETY BUILDING.

WHEREAS, on December 6, 2016, the City Commission authorized negotiations with AECOM Technical Services, Inc., selected as a result of an RFQ process, as the design consulting firm for a new Public Safety Building; and

**WHEREAS**, on March 28, 2017, the City Commission approved a contract with AECOM Technical Services, Inc. for Public Safety Building Design Consulting Services; and

WHEREAS, AECOM is requesting additional design services in the amount of \$290,000 for scope revisions to the project based on added program square footage, increased construction budget, and extended design schedule duration; and

**WHEREAS**, the building square footage grew from 161,000 SF to 189,000 SF and the cost increased from \$37M to \$52M; and

WHEREAS, AECOM's fees are aligned with the previous/existing pricing structure when they were originally awarded the services;

# NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

- **SECTION 1.** The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.
- **SECTION 2.** That the City Commission approves AECOM's additional design services request in the amount of \$290,000.
- **SECTION 3.** That this Resolution shall become effective upon the date of its adoption herein.

Dear Ernesto:

AECOM is requesting additional services for the scope revisions to the project based on the added program square footage along with the increased approved Owners Construction Budget and the extended design schedule duration as noted below.

#### **Scope of Services**

The original scope of work and basis of our proposal dated March 21, 2018 was for a 161,000 square foot building with a construction cost of \$36.7M and a design schedule of 110 days to complete the Schematic Design. (See attached Basis of Propsal and Project Schedule).

The final approved design incorporated and additional 28,000 SF of increased program square footage to the building as requested by the users. From 161,000 SF to 189,000 SF (or an increase of 17%).

The approved construction cost for the building increased \$11.7M. From \$36.7M to \$48.4M (or an increase of 31%).

The original design schedule had proposed 110 days from NTP to the Approval of the Schematic Design. The actual duration was 264 days for an additional 154 days (or 22 weeks). The extended schedule included numerous additional meetings and presentations to the owner to review the added scope and requested plan revisions based on user comments.

#### **Deliverables**

Along with the approved 5-story Schematic Design, additional concepts and estimates were developed and submitted for an alternate 4-story version in an effort to reduce the projects overall construction cost and schedule.



#### Compensation

AECOM's fees for professional services rendered related to this additional effort shall be \$290,000.00.

#### Schedule

The work has been completed however an additional 154 days was added to the schedule to incorporate the revised scope.

#### F. BASIS OF PROPOSAL

The following assumptions have been made for the preparation of this proposal:

- 1. Per the AECOM provided Concept Cost Estimate (dated March 8, 2107), the anticipated construction cost including escalation to midpoint of construction (assumed June 2019) and contingencies is \$32.8M for the Public Safety Building and \$3.9 M for the parking garage. \$36.7M
- 2. Per the Concept Program, the Coral Gables Public Safety Building is anticipated to be approximately 104,000 SF. The Garage is anticipated to house 160 Vehicles at approximately 57,000 SF 161,000 SF
- 3. Per the Site Selection Committee Presentation 8 December 2015, the site will be Lot 6 Scenario #2. It is anticipated that the existing alley will be vacated. See attached Scope of Services for this task.
- 4. The project will be designed to achieve LEED Silver certification.
- 5. New traffic signals may be incorporated into the design based on the Traffic Survey.
- 6. Utility relocations and off site utilities upgrades are not anticipated.
- 7. Site and Building Permit fees shall be waived or shall be paid by the City.
- 8. USGBC LEED registration fees shall be paid by the City.
