LEGAL DESCRIPTION:

PARCEL 1

Tract "I" being a portion of Tract 1 of the Amended Plat of JOURNEY'S END, Plat Book 34, at Page 89 of the Public Records of MIAMI-DADE County, Florida, described as follows:

Commence at the NW corner of Tract 1 of the said JOURNEY'S END; thence South 1 degree 20 minutes 30 seconds East along the West line of the said Tract 1 for a distance of 1031.81 feet to the point of beginning of the tract of land herein described; thence North 87 degrees 54 minutes 30 seconds East parallel to the North line of the said Tract 1 for a distance of 537.46 feet to the Westerly right-of-way line of Old Cutler Road as the same is shown on the Plat thereof, recorded in Plat Book 50 at page 56, of the Public Records of MIAMI-DADE County, Florida, thence Southerly along the Westerly right-of-way line of the said Old Cutler Road for a distance of 225 feet to a point; thence South 87 degrees 54 minutes 30 seconds West for a distance of 294 feet to a point; thence North 38 degrees 30 minutes 58 seconds West for a distance of 151.61 feet to a point; thence south 87 degrees 54 minutes 30 seconds West for a distance of 118 feet to a point on the West line of the said Tract 1; thence North 1 degree 20 Minutes 30 seconds West along the West line of the said Tract 1 for a distance of 100 feet to the Point of Beginning.

PARCEL 2

A portion of Tract 1 of the Amended Plat of JOURNEY'S END, according to the Plat thereof, as recorded in Plat Book 34, at Page 89, of the Public Records of Miami-Dade County, Florida, described as follows:

Commence at the N.W. corner of Tract 1 of the said JOURNEY'S END; thence South 1 degree 20 minutes 30 seconds East along the West line of the said Tract 1 for a distance of 1131.81 feet to the Point of Beginning of the tract of land herein described; thence North 87 degrees 54 minutes 30 seconds East parallel to the North line of said Tract 1 for a distance of 118 feet to a point, thence South 38 degrees 30 minutes 58 seconds East for a distance of 151.61 feet to a point; thence North 87 degrees 54 minutes 30 seconds East parallel to the North line of said Tract 1 for a distance of 294 feet to the Westerly right-of-way line of Old Cutler Road as the same is shown on the Plat thereof recorded in Plat Book 50 at Page 56, of the Public Records of Miami-Dade County, Florida; thence Southerly along the Westerly right-of-way line of the said Old Cutler Road for a distance of 100.49 feet to the intersection thereof with the South line of the said Tract 1; thence West along the South line of the said Tract 1 for a distance of 488.49 feet to the SW corner of the said Tract 1: thence North 1 degree 20 minutes 30 seconds West along the West line of the said Tract 1 for a distance of 219.16 feet to the Point of Beginning.
