I want to make sure that when a contractor comes to the City of Coral Gables, that they're given some sort of document stating exactly where this type of turf is allowed because I've already gotten two emails from people saying, hey, I installed it. This is not just like installing a bench, you know, for \$500. This is thousands and thousands of dollars that people are going out and installing without having the -- you know, without having adhered to, again, this new rule. So, I want to make sure that people are aware -- landscapers, contractors, people who are coming to the City to renovate their homes or people who are contemplating buying here that, yes, we do allow this type of product -- if we approve it on second reading -- but there are parameters and we have -- certain things have to be followed.

City Manager Iglesias: And a permit is required.

Vice Mayor Lago: Yeah, that...

have this implementing order, it's not so incredibly broad now all of a sudden the only thing you're doing all day long is analyzing these things. So, I would encourage that this be revised to be a little bit more specific for your own benefit.

Public Services Division Director Dannemiller: Yes.

Commissioner Quesada: Because you're going to go from doing all these different things to one thing only. I have a feeling that's coming. I think there should also be very clear, defined -- you're seeing a lot of front yards, the driveways now, that you're getting a concrete block and then the grass around. Maybe you do some pictures making it clear so that -- I think you're going to see it more and more and more because I've had a few residents approach me about it like, oh, they made us do this other type of thing. And I think if you're very clear about that -- again, I don't want staff to be overburdened, so I'm telling you this for your own benefit.

Planning and Zoning Director Trias: Commissioner Quesada, in terms of the driveways, I'm thinking that the best way to approach it is to think of the artificial turf as something other than landscape. It is not landscape, so it could be part of the surface that is allowed in a -- yeah.

Commissioner Quesada: Whatever you decide. I'm just -- I see it more and more.

Planning and Zoning Director Trias: Yeah.

Commissioner Quesada: And I hear people talking about it more and more, so I think you're going to see more of it.

Planning and Zoning Director Trias: The easiest thing is it's not landscape. It's something else, so let's look at it as -- yeah.
