RESOLUTION NO. 2019-63

A RESOLUTION ACCEPTING THE RECOMMENDATION OF THE PROCUREMENT OFFICER TO WAIVE THE COMPETITIVE PROCESS OF THE PROCUREMENT CODE AND PURCHASE THE MOBILEEYES SOFTWARE SERVICES PLATFORM ANNUAL MAINTENANCE SERVICE AS A SPECIAL PROCUREMENT/BID WAIVER, PURSUANT TO SECTIONS 2-689 AND 2-691 OF THE CITY'S PROCUREMENT CODE.

- **WHEREAS**, the Information Technology purchased the MobileEyes Software Platform in September 2009 to operate Fire Department mobile field public safety inspections; and
- WHEREAS, the MobileEyes system supports the electronic processes for all Fire Safety field inspection tasks performed citywide by Fire Department Inspectors; and
- **WHEREAS**, the system also allows the Fire Department staff to access the platform services, record fire safety compliance for business and home code compliance, conduct this business process in the field, and subsequently produce financial report from the system; and
- **WHEREAS**, the IT Department has the need to renew the annual maintenance of the MobileEyes Platform for a period of one (1) year at \$25,970 per year; and
- **WHEREAS**, the City is seeking approval to purchase the maintenance for the existing MobileEyes system that includes licensing access, support maintenance, cloud services, hosting fees, and user tools; and
- WHEREAS, Section 2-691 of the Procurement Code entitled "Special Procurement/Bid Waiver" authorizes the Procurement Officer to initiate a special procurement/bid waiver when an unusual or unique situation exists that makes the application of all requirements of competitive sealed bidding or competitive sealed proposal contrary to the public interest; and
- WHEREAS, Section 2-585 of the Procurement Code, entitled "Authority" authorizes the City Manager to delegate authority to the Procurement Officer to administer and make recommendations on contract awards;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

- **SECTION 1.** The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.
- **SECTION 2.** That the City Commission accepts the recommendation of the Procurement Officer and authorizes the City Manager to purchase MobileEyes Software Platform annual maintenance service, pursuant to Section 2-691 of the City's Procurement Code.
- **SECTION 3.** That this Resolution shall become effective upon the date of its passage and adoption herein.
