Daniel – Was at the last S.A.B. meeting speaking about the issues he was having on Solar Panels. Since then, he heard that several other homeowners were denied as well. He is here today, asking the Board to please encourage the City Officials to adopt new aesthetic guidelines on Solar Panels.

January Commission Meeting Updates -

- The Commission adopted on second reading and it passed unanimously, on increasing the membership on the Sustainability Advisory Board. The Board will now have a member of the University of Miami, The Chamber of Commerce and FIU.
- The Commission passed on second reading an ordinance on prohibiting plastic straws and stirrers
 on City Facilities, City Parks, Special Events Permits and by City Contactors and Vendors. An
 exemption was added for individuals with disabilities.

Luiz suggested that other plastics, other than bags and straws be added to the resolution. Matt is already speaking with his counterparts in Miami Beach in reference to the Plastic Free Miami Beach Campaign, to incorporate Coral Gables into that.

Coral Gables Solsmart Application/Designation—the City is currently working with SolSmart, a Department of Energy Organization who is providing free consulting to cities on how to provide their solar permitting and zoning process, aesthetics is going to be a much larger discussion. The Planning and Zoning Director, Development Services Director and the City Manager will be meeting with Matt and the Consultant next week, to discuss the application.

Irela mentioned that there was a resolution sponsored by Commissioner Rebecca Sosa; it went through committee and passed, establishing a Biscayne Bay Taskforce. It will be going to the County Commission for approval in February. Irela said the Board should ask the Commission to send their support.
