A question was brought to me yesterday regarding the legal description but that may need to be changed. The resolution needs to be adopted by four-fifths vote in order to waive the Procurement Code and because of the amount. It is a public hearing item.

Mayor Valdes-Fauli: Anybody wishes to be heard?

Commissioner Quesada: Are there any changes between first and second?

City Attorney Ramos: F-2 – yes.

Commissioner Quesada: Any changes other than the 65/35 that we discussed yesterday.

City Attorney Ramos: So that was a separate resolution, there were no changes between first and second to the ordinance itself.

Mayor Valdes-Fauli: Do I hear a motion?

Commissioner Quesada: That goes to your comment.

Vice Mayor Lago: Which deals with the proceeds. Again, I'm opposed to selling this piece of property...The reason why I'm going to vote in favor of it, I'm going to be very clear is because those proceeds are going to be used again, to buy property in the City, to buy actual parks that will be used by the residents of this community. Again, like most of my colleagues on this Commission, we want to make sure that we are in the business of making sure the City is financially sound as possible. We understand that a real estate portfolio brings that financial liability. So Commissioner Mena, about a year ago, made a very good point, which was the issue of using some of these park impact fees to be able to kind of revamp some of these projects, some of these pieces of property that we are buying. So, I proffer that in regards to this sale, which is going to bring about \$3 million dollars to the park trust, so I think it's a great idea to do it.

City Attorney Ramos: A motion was taken at the last meeting to use the \$3 million for parks, the 65 to acquisition and 35 to enhancement.

Mayor Valdes-Fauli: Do I hear a motion?

Commissioner Quesada: So moved.
