A RESOLUTION ACCEPTING THE CITY CLERK'S CERTIFICATION AND DECLARATION OF THE RESULT OF THE CITY OF CORAL GABLES GENERAL BIENNIAL ELECTION, WHICH WAS HELD ON APRIL 9, 2019, WHICH RESULTED IN A RUN-OFF ELECTION ON APRIL 23, 2019 WHEREIN VOTERS ELECTED RALPH CABRERA AND JORGE FORS, TO PARTICIPATE IN SUCH RUN-OFF ELECTION SCHEDULED FOR APRIL 23, 2019.
