are in violation of the following sections and subject to Section 101-107 of the City Code of the City of Coral Gables by:

### **City Code - Chapter 105. Minimum Housing.**

**Failure to maintain the building water tight. Tenants are having water intrusion problems in their units due to water penetrating the exterior walls of the building. Engineer's report attached indicating as such.**

#### **The following steps should be taken to correct the violation:**

**Remedy:** Must make necessary repairs to exterior of building to remediate water intrusions and pooling of water throughout decks around the building.

As a result of the above violation(s), a complaint has been filed against you and you are hereby commanded to appear before the Code Enforcement Board for a hearing on 5/22/2019 at 8:30 am in the Commission Chambers, located on the second floor of:

**If this notice pertains to failure to maintain a historic structure, please be advised that:**

- You may be subject to substantial fines that may not be mitigated.
- You may also be required to repair or restore the historic structure.
- If the historic structure is allowed to deteriorate to the point where it must be demolished:
  - the City Code requires that you replace the structure with a similar historically-appropriate structure; and
  - the property will no longer qualify for an historic preservation tax exemption.
