RESOLUTION NO. 2019-108

A RESOLUTION OF THE CITY COMMISSION ACCEPTING THE RECOMMENDATION OF THE PROCUREMENT OFFICER TO WAIVE THE COMPETITIVE PROCESS OF THE PROCUREMENT CODE AND ENGAGE MULTIPLE FIRMS FOR SPECIALIZED ENGINEERING SERVICES AS A SPECIAL PROCUREMENT/BID WAIVER, PURSUANT TO SECTION 2-691 OF THE CITY'S PROCUREMENT CODE.

WHEREAS, the City has identified a serious need for structural peer review, threshold inspections and special inspector services; and

WHEREAS, the need is based on the fact that the City is currently involved in several major construction projects; and

WHEREAS, it is critical that the City has immediate access to firms that can provide the specialized engineering services to conduct critical process reviews that can assist with eliminating costly errors during the construction phase; and

WHEREAS, the City has identified multiple highly qualified firms that can be used on an as needed basis and based on the availability of funds at the time of the need; and

WHEREAS, the firms that will be utilized are Brill Rodriguez Salas & Associates, Inc., De Los Reyes Engineering and Douglas Wood & Associates; and

WHEREAS, Section 2-691 of the Procurement Code entitled "Special Procurement/Bid Waiver" authorizes the Procurement Officer to initiate a special procurement/bid waiver when an unusual or unique situation exists that makes the application of all requirements of competitive sealed bidding or competitive sealed proposal contrary to the public interest; and

WHEREAS, Section 2-585 of the Procurement Code, entitled "Authority" authorizes the City Manager to delegate authority to the Procurement Officer to administer and make recommendations on contract awards;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. That the City Commission accepts the recommendation of the Procurement Officer and authorizes the City Manager to engage Brill Rodriguez Salas & Associates, Inc., De Los Reyes Engineering and Douglas Wood & Associates for specialized engineering services on an as needed basis and based on the availability of funds at the time of the need, pursuant to Section 2-691 of the City's Procurement Code.

SECTION 3. That this Resolution shall become effective upon the date of its passage and adoption herein.
