RESOLUTION NO. 2019-111

A RESOLUTION OF THE CITY COMMISSION ACCEPTING THE FLORIDA RECREATION DEVELOPMENT ASSISTANCE PROGRAM (FRDAP) GRANT IN THE AMOUNT OF \$50,000.00 TO MAKE IMPROVEMENTS TO THE NEWLY DESIGNED AND BUILT BETSY ADAMS AND CORAL GABLES GARDEN CLUB PARK LOCATED AT 4650 ALHAMBRA CIRCLE, CORAL GABLES, FLORIDA AND AUTHORIZING AN AMENDMENT TO THE FISCAL YEAR 2019 ANNUAL BUDGET TO RECOGNIZE THE \$50,000.00 GRANT AS REVENUE AND TO APPROPRIATE SUCH FUNDS TO COVER THE GRANT EXPENDITURES.

WHEREAS, the City was awarded a FRDAP grant in the amount of \$50,000.00 for improvements to the newly-designed and built Betsy Adams and Coral Gables Garden Club Park located at 4650 Alhambra Circle, Coral Gables, Florida; and

WHEREAS, the Agreement will provide funding to reimburse improvements to the Betsy Adams and Coral Gables Garden Club Park; and

WHEREAS, an amendment to the Fiscal Year 2018-2019 Annual Budget is required to recognize the \$50,000.00 grant as a reimbursement and to appropriate such funds to cover the grant expenditures;

NOW THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. The foregoing “Whereas” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.


SECTION 2. That the City of Coral Gables, including its Community Recreation Departments, is hereby authorized to accept the FRDAP Grant monies in the amount of \$50,000.00.

SECTION 3. That the City Commission hereby authorizes an amendment to the Fiscal Year 2019 Annual Budget to recognize the \$50,000.00 grant as reimbursement and to appropriate such funds to cover the grant expenditures.
