RESOLUTION NO. 2019-112

A RESOLUTION OF THE CITY COMMISSION ACCEPTING THE FLORIDA RECREATION DEVELOPMENT ASSISTANCE PROGRAM (FRDAP) GRANT IN THE AMOUNT OF \$50,000.00 TO MAKE IMPROVEMENTS TO THE FUTURE MAGGIORE PARK LOCATED AT 5028 MAGGIORE STREET, CORAL GABLES, FLORIDA AND AUTHORIZING AN AMENDMENT TO THE FISCAL YEAR 2019 ANNUAL BUDGET TO RECOGNIZE THE \$50,000.00 GRANT AS REVENUE AND TO APPROPRIATE SUCH FUNDS TO COVER THE GRANT EXPENDITURES.

WHEREAS, the City has been awarded a FRDAP grant in the amount of \$50,000.00 for improvements to the future Maggiore Park located at 5028 Maggiore Street, Coral Gables, Florida; and

WHEREAS, the Agreement will provide funding to reimburse design and construction costs for the future Maggiore Park; and

WHEREAS, an amendment to the Fiscal Year 2019 Annual Budget is required to recognize the \$50,000.00 grant as a reimbursement and to appropriate such funds to cover the grant expenditures;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. The foregoing “Whereas” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.


SECTION 2. That the City of Coral Gables, including its Community Recreation Departments, is hereby authorized to accept FRDAP Grant monies in the amount of \$50,000.00.

SECTION 3. That the City Commission hereby authorizes an amendment to the Fiscal Year 2019 Annual Budget to recognize the \$50,000.00 grant as reimbursement and to appropriate such funds to cover the grant expenditures.

SECTION 4. That this Resolution shall become effective upon the date of its passage and adoption herein.


