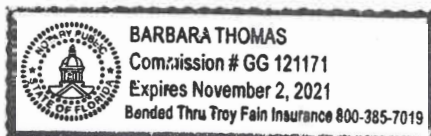

NOTICE OF PUBLIC HEARING

All interested parties are hereby notified that the Board of Adjustment of the City of Coral Gables, Florida, will hold a public hearing for the purpose of hearing variance requests and taking action on such requests, reviewing and taking action on appeals from Administrative Officials, and other matters, as outlined in Section 2-401 of Ordinance No. 2007-01, as amended and known as the "Zoning Code" of the City of Coral Gables, Florida, to wit:

Case No. BA-19-07-5225

Requests: Variance for the property located at 430 Costanera Road

1. Variance to allow a boat lift to extend thirty-three feet and five inches (33'-5") from the mean high waterline vs. watercraft lifts or floating watercraft lifts shall not extend beyond twenty-five (25) feet from the banks of waterways, pursuant to Appendix A Section A-23 Cocoplum Section Two (2) and Section 5-805(E) of the Coral Gables Zoning.
2. Variance to allow Floating Vessel Platform to extend thirty feet and seven inches (30'-7") from the mean high waterline vs. watercraft lifts or floating watercraft lifts shall not extend beyond twenty-five (25) feet from the banks of waterways, pursuant to Appendix A Section A-23 Cocoplum Section Two (2) and Section 5-805(E) of the Coral Gables Zoning.

Interested parties may express their views at the hearing or file them in writing with the undersigned on or before the commencement of the hearing which will be held before the Board of Adjustment of the City of Coral Gables at City Hall, 405 Biltmore Way, in the Commission Chamber, Coral Gables, Florida, commencing at **8:00 A.M., Monday, August 5, 2019.**

If a person decides to appeal any decision made by a board / committee with respect to any matter considered at a meeting or hearing, that person will need to ensure that a verbatim record of the proceedings is made, which record includes the testimony and evidence upon which the appeal is to be based.
