RESOLUTION OF CITY Α THE COMMISSION AUTHORIZING SATCHMO BLUES BAR AND GRILL, INC. TO SELL ALCOHOLIC BEVERAGES AT THE PLAZA LOCATED ΑT 60 MERRICK WAY **BEGINNING** THURSDAY, OCTOBER 3, 2019, THROUGH SUNDAY, OCTOBER 6, 2019, AND THURSDAY OCTOBER 10, 2019 THROUGH SUNDAY, OCTOBER 13, 2019, DURING THE **OKTOBERFEST** EVENT; SUBJECT TO FLORIDA PROFESSIONAL REGULATION **DEPARTMENT** OF REQUIREMENTS.

WHEREAS, Satchmo Blues Bar and Grill, Inc. has requested permission to sell alcohol at the plaza located at 60 Merrick Way during its *Oktoberfest* event; subject to Florida Department of Professional Regulation requirements; and

WHEREAS, national and local bands will perform during the event, but there will be no outdoor music after 11:00 p.m. on Thursdays through Saturdays and after 8:00 p.m. on Sundays; and

WHEREAS, this request has been reviewed by the City's Special Events Committee;

## NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

**SECTION 1.** That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon the adoption hereof.

**SECTION 2.** That Satchmo Blues Bar and Grill be authorized to sell alcoholic beverages during its **OKTOBERFEST** event, subject to State of Florida requirements, as follows:

- (a) on Thursday, October 3rd and Thursday, October 10, from 6:00 p.m. until 10:00 p.m.;
- (b) on Friday, October 4 and Friday, October 11 from 6:00 p.m. until 11:00 p.m.;
- (c) on Saturday, October 5th and Saturday, October 12th from 3:00 p.m. until 11:00 p.m.; and
- (d) on Sunday, October 6th and Sunday, October 13th from 2:00 p.m. until 8:00 p.m.

**SECTION 3.** That this Resolution shall become effective upon the date of its passage and adoption herein.
