LAMAR LOUISE CURRY PARK: The design plans are in the process. They will be presented before the Garden Club on September 23, 2019. The buble speech benches will be relocated. Katherine Cathers will handle the relocation. Ms. Bell encouraged the board to submit recommendations for the new bench locations.

DISCUSSION: The plant donations by Pure Beauty Farms are being planted on Miracle Mile. They will also be planted at the Historic Entrances. These plantings are being handled by Landscape Services. A consultant was hired to handle the maintenance of the fountains throughout the city. The court house is responsible for the deteriorated landscape. Code Enforcement will look into it.
