It was a pleasure talking to you upon receiving Notice if the above mentioned application.

I am the owner and resident of <u>7155 Los Pinos Blvd</u> and as I explained to you I am very concerned with the requested variance which, if approved, will likely block the access and egress from my property by the waterway.

The canal is already very narrow and with the existing docks, lifts and massive mangrove in both sides of the canal make it very difficult for me and for other to navigate. Encroaching one more boat lift and narrowing even more the passage will block the passage for those with a bigger boat like myself. This is the only way I can navigate once going under the bridge is not an option once there is not enough clearance.


On top of this, as you will see from the attached pictures, the house next door to 7140 is also abusing their right to dock at their dock and currently have two boat docked. I would appreciate if you can notify code enforcement so they can address these violations with the owners.


Please accept this as my formal opposition to the requested variance and request that the application be denied so that the unobstructed navigable waterway comply with the Coral Gables Zoning Code.


