## **RESOLUTION NO. 2019-264**

A RESOLUTION OF THE CITY COMMISSION AUTHORIZING A CHANGE ORDER TO THE "CYCLOMEDIA DATA SERVICES" CONTRACT, PROFESSIONAL SERVICES AGREEMENT NO. 2019-003 WITH CYCLOMEDIA TECHNOLOGY, INC., PURSUANT TO SECTION 2-764(B), APPROVAL OF CHANGE ORDERS AND CONTRACT MODIFICATIONS, IN THE AMOUNT OF \$44,065 FOR ADDITIONAL RIGHT-OF-WAY ASSETS TO BE EXTRACTED BY CYCLOMEDIA AND ENTERED INTO CARTEGRAPH OPERATIONS MANAGEMENT SOFTWARE.

WHEREAS, the CycloMedia professional and data services will allow the City to possess and maintain an inventory of signage, street features, pavement and sidewalk infrastructure in a comprehensive and accurate data structure that horizontally integrates with other City systems; and

WHEREAS, on January 22, 2019, Resolution No. 2019-28 was approved and on March 7, 2019 Professional Services Agreement No. 2019-003 was executed with CycloMedia Technology, Inc. to inventory 267 lane miles and several assets in the public right-of-way, which included: signs, ADA pedestrian ramps, storm drains, sidewalks and cross slopes, curb and gutters, and a road condition analysis; and

WHEREAS, this change order consists of additional right-of-way assets including, streetlights, utility poles, bus benches and shelters, trees, street name monuments, manholes, traffic circles, crosswalks, and three other miscellaneous assets to be determined later; and

WHEREAS, it is expected that the City will realize operational efficiencies and cost savings by utilizing CycloMedia's professional and data services;

## NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

**SECTION 1.** The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

**SECTION 2.** That the City Commission does hereby approve the Change Order in the amount of \$44,065 for this project, pursuant to Section 2-764(b) of the City's Procurement Code.

**SECTION 3.** That this Resolution shall become effective upon the date of its passage and adoption herein.
