City Attorney Ramos: A Resolution accepting the recommendation of the Procurement Officer

Assistant Procurement Finance Director Walker: Good afternoon. Celeste Walker, Assistant

Finance Director for Procurement. This particular project is an award for the disaster

monitoring, which I'm sure you're all looking forward to. This portion of the contract is for the

contractor to monitor the debris collection, the reduction, and also assist with FEMA collection.

We had one responsive, responsible bidder, that was Tetra Tech, Inc. It was evaluated by a

professional committee of internal and external members. This particular company is well-

versed in disaster recovery. They've been performing the services for 17 years. We did an

exhaustive due diligence report. They do not have any issues or concerns with litigations. They

have excellent performance reviews, and we are recommending we move forward with the

award.

Assistant Procurement Finance Director Walker: Yes.

Commissioner Lago: First off, you mentioned it was the only sole responsive proposer.

Assistant Procurement Finance Director Walker: That's correct.

Commissioner Lago: After what we went through after not having a storm for 15 years and we saw that we had some issues in regards to monitoring and getting firms to pick up debris in a timely manner because it was -- again, we were spread thin, multiple storms. Do you think it's in the best interest of the City to potentially have more than just one firm? Maybe we can go out again, in four or five months, and find another firm to add to the mix, kind of like what we have with the CM at-risk contract, where those -- which I have multiple of those contracts -- you're prequalified, and then they just start giving you the work because you've been prequalified through a thorough, you know, process.

Assistant Procurement Finance Director Walker: This particular contract is for the monitoring portion. It's not for the actual debris...

Commissioner Lago: No, no. I understand that.

Assistant Procurement Finance Director Walker: Okay.

Commissioner Lago: I understand that.

Assistant Procurement Finance Director Walker: So, for the debris collection, that's where we have multiple vendors.

Mayor Valdes-Fauli: Yeah, but monitoring...

Commissioner Lago: You don't think we...

Mayor Valdes-Fauli: They would be stepping on each other.

Commissioner Lago: I'm just asking, have you -- maybe you have different...

Mayor Valdes-Fauli: Monitoring.

Commissioner Lago: Maybe you have different sites or -- the reason why I'm asking is because

the -- you know, I just read and I looked over their information. They seem very capable.

Actually, they were being hired by Key Biscayne. They were just hired by Key Biscayne to do

an analysis of their response, you know, in reference to recovery. I think it was a \$135,000

contract. I was reading online yesterday. So, I want to make sure that we're not spread too thin

where this firm is being hired by other municipalities and if we do have some sort of disaster,

like what happened with Irma, that we are priority number one.

Assistant Procurement Finance Director Walker: Correct. With that particular -- with this

particular, I guess, phase of the services, it is traditional that only one contractor is hired for

actual monitoring services. So, we surveyed six other municipalities, and again, they, too, only

hire one particular contractor for this portion of the services. For this other portion, as far as

disaster recovery or the collection of the debris, that is when we actually engage multiple

providers to be able to service and provide the needs that we have.

Commissioner Lago: And are we sure that -- like I mentioned, you know, make sure you read up

-- and not that you haven't -- but the Islander News from Key Biscayne. They're being hired to

do a thorough analysis in reference to debris hauling vendors and all kinds of different things and

monitoring and give their input. What I want to make sure is that not 34 municipalities are

hiring Tetra Tech, and if something happens, and then everybody is, you know, saying, hey,

Tetra Tech. We want to be your number-one people. Come on. We have a contract with you,

which is kind of like what happened with our debris hauling.

Assistant Procurement Finance Director Walker: Correct.

Commissioner Lago: So...

Commissioner Lago: And I know you can't -- you don't have a crystal ball and I'm not -- I'm

just saying...

municipalities, which also lends to their credibility for having the background and the capability

to providing the services. With regard to their capacity, when we actually get into negotiations

to discuss that, that is part of the conversation for us to make sure they haven't overextended

themselves and that they can and in fact perform according to the standards for the City, so that

would be what we would be engaging in when we...

Comprehensive Emergency Management Plan and Hurricane Plan, which were developed in

2006 for the island. So, maybe it's an opportunity to some...

City Manager Swanson-Rivenbark: So, we have a COOP plan that is being updated right now...

Commissioner Lago: Okay.

City Manager Swanson-Rivenbark: With an outside consultant, All Hands Consulting, which I

believe the County has also used.

Assistant Procurement Finance Director Walker: Yes.

City Manager Swanson-Rivenbark: So, we're at similar levels...
