And, when you have all these individuals in the room today, it is my duty to make sure that at least we hear a handful of the individuals that are here that may represent the opinions -- no matter what side they're on -- their opinions should be heard. amount of time. I also have to leave here at 12 o'clock -- I will be back -- because I have to be

somewhere for work from 12 to 1. But again, if we can listen to a handful of individuals who

will treat this with respect, I think it's in the best interest of not only this Commission, but the

City. But again, like I mentioned before, I will do whatever this Commission decides. I'm

willing to listen, as always.

Mayor Valdes-Fauli: Let me see if I can reach a halfway point here. The issue before us is the

administrative investigation report and the reprimand, the six-page reprimand, which has been

withdrawn. There's also a bigger issue here, and that is the relationship between the City

Manager, the Chief of Police, and the need or not need for a public safety officer on top of the

Chief of Police. And -- on top of the Chief of Police and also interfering with the running of the

Police Department. That's another issue, and I am very, very willing to put that issue at the next

Commission meeting -- the next Commission agenda, to discuss it because that issue, I think,

pervades what has happened here. And I -- the issue before us here was, again, the reprimand,

the administrative complaint, and the conclusions of the investigator, which is this thick thing

here, which exonerated Chief Hudak. With your pleasure -- I mean, with your consent, I would

like to put the discussion of this item off until the next Commission meeting, where we will

discuss...

the Chief say that he will work with the Manager, he will work with the Public Safety Director,

he will be part of whatever strategic plan that comes forward for the City. But, I think the issue

Fausto Gomez: Briefly, Mr. Mayor, Mr. Vice Mayor...

Mayor Valdes-Fauli: One minute.

Mr. Gomez: Commissioners. Fausto Gomez. I have the pleasure of residing in Coral Gables for 32 years, serving as your lobbyist for over 20 years, and I still maintain significant property holdings in the City, and I conduct my professional and social life here. I have standing to speak in front of you. I am here on behalf of my friend, Chief Ed Hudak, and I appreciate the Manager withdrawing her memorandum. Frankly, that memorandum was an embarrassment and it has placed you and this City with all these cameras. It has placed us in a position as residents and property owners that we have had national, international and local press on an issue that was decided and that memoranda should never have been issued. I commend you, quite frankly, for having a discussion about the organization of the City. I look forward to that. Thank you very much.

Mayor Valdes-Fauli: Thank you, Fausto. Juan Diaz.

Vice Mayor Quesada: Well, actually, Gus is here.

Commissioner Mena: Gus Fonte is here.

Mayor Valdes-Fauli: What?

Commissioner Mena: Gus Fonte...

Mayor Valdes-Fauli: Oh, you're here.

Gus Fonte: (INAUDIBLE) Gus Fonte, 2100 Ponce de Leon Boulevard. I've served the City for a member of the BID for 16 years and as a member of the Economic Development Board for four years. I would ask that -- having given my time and effort to the City, that the Commission would listen to what I have to say, and it's very simple. I support the Chief. Chief Hudak has been a friend to my family and a very valuable employee of this City, and I would ask you for his continued support. Thank you.

Commissioner Lago: Thank you, sir.

Mayor Valdes-Fauli: Thank you, sir.

Commissioner Lago: Please.

Mayor Valdes-Fauli: Juan Diaz.

Juan Diaz: Yes.

Mayor Valdes-Fauli: And after Juan Diaz comes, Millie Ruiz Garcia Navarro.

Mr. Diaz: Good morning.

Commissioner Lago: Good morning.

Mayor Valdes-Fauli: Good morning, sir.

Mr. Diaz: I've owned a business here in the City of Coral Gables for nearly 20 years. I've known Ed for probably around 20 years. He's an exceptional person as a friend, a father, and as a professional. A quick story that I want to share would show you the quality of person that he is in a moment when we need to back the blue more than ever, because of the assault that they've been under. Hurricane Irma, we've been through many hurricanes and this -- and I'm going to explain to you never happened before. It happened only with Ed. I called in because we're on the highway in front of UM and it gets chaotic during the hurricanes when I needed police help to keep the lines and the people from arguing and fighting. He called me back and told me, let me see what I can do because I've got my guys and girls going dual duty. Let me see how I can organize it, because I've got to go ahead and take care of the City issues first. He called me back an hour later and he told me I can get you some guys. We'll have them there in the morning. I told him, thank you very much, Ed. About an...

Mayor Valdes-Fauli: Finish up.

Mr. Diaz: Huh?

Mayor Valdes-Fauli: Finish up.

Mr. Diaz: About an hour later, he called me back and he told me, I need you to do something for me. Can we set up a line for our police officers and firefighters to fuel up, because their families are at home and they're not able to do that for their families? I hung up the phone and I said to

myself, that's a true leader. That's the type of person you want in charge of a police department.

Mayor Valdes-Fauli: Thank you very much.

Millie Ruiz Garcia Navarro: Good morning to all of you, Mayor and Commissioners, and

everyone in the room. I am here supporting Chief Hudak. I had the pleasure of working with

Alina Hudak in Miami-Dade County. I've known the kind of family they are, always admired

their family, and he's a very decent, honest person. And, I don't even have to tell you what kind

of Chief you have had for all these years. The crime has been reduced. And, we have to

acknowledge that the work he has done for the City is amazing. I believe it's shameful the

amount of money that you all have spent, \$50,000, on an investigation that had not supposed to

be made. I believe it's unreal. It's childish, and we should reprimand the person that was

involved in that investigation.

Mayor Valdes-Fauli: Thank you, ma'am.

Ms. Ruiz Garcia Navarro: I thank you, sir.

His dedication, professionalism and loyalty has been unmatched, the highest standards. Again, something we can't say about certain individuals. So, a letter was removed under the pressure of citizens. We're facing nepotism in this City like never heard before. And, it's you guy's move and it's your job to listen to us. Have the hearing. involved in the "incident" have been dragged through the mud. We deserve better. We really do

deserve better. And, something Commissioner Keon raised that I think is happening throughout

the country, but we should fight it here is that if we want to attract high-caliber public servants,

That's why all these people are here today. It's not just about supporting Ed Hudak. It's not just about seeing 14 police professionals have their names dragged through the mud over an investigation that, quite frankly, you know, was unwarranted given the fact that Chief Hudak has a three-decade long career in this police department. I urge you to take up this matter today, okay, resolve this problem today. Stop kicking the can down the road. You've been doing it for four years, okay. You respond to the people in this room. It's not vice versa, Ms. City Attorney. I understand there's decorum, but enough is enough.

Mayor Valdes-Fauli: Thank you, sir. David Bernhardt, and then, Osi Rind. David. Good

morning, sir.

David Bernhardt: Good morning, Council. David Bernhardt, Tallahassee, Florida. I am

currently the vice president for the State of Florida Fraternal Order of Police. My background is

a 29-year command staff veteran. I am currently a chief of staff for a constitutional officer here

in the state of Florida. Many people are here to support the chief. I am here to support the

wrong accused female officers. It is my understanding hundreds of records pertaining to the

investigation were not given to the local FOP after a lawful public records request was made.

And may I remind the council that several Martin County Commissioners have recently been

charged and arrested for not following the Sunshine Law and not releasing the public records.

It's my understanding during the investigation the Bill of Rights for these officers were violated.

In fact, these victims were not given their (INAUDIBLE) and their equal rights as victims are

allowed. I know President Jenkins of the FOP addressed the stellar service of the Chief and

addressed the history of your City Manager. But you also forget named in the complaint, all the

public sees is how the City fails to protect its officers. And in this case, these female officers

were victims of cyber bullying. May I go -- may I go -- may I have the pleasure for one...

the support here for your Chief and officers. So, your own future, I believe, lies in the action or

inaction you take to resolve this matter. And without question, I think you know where the

residents and voters support and who they hold their trust in. Thank you.

sent this anonymous letter. The anonymous letter that, before the investigation even started, we

told you had no factual basis; that it was false, that none of these women had written that letter.

To date, the Administration still refuses to investigate who sent that letter. And, these women

and this union is here to ask you to direct the Administration to do exactly that. They have an

obligation to do that. There are Charter provisions. There are ordinance provisions that allow

you to investigate this and -- the union -- that's the union's and these officers' request.

was provided to us. There was a legal affairs post on July 30. That post went out at 8:03 -- I'm

sorry, the 27th. That post went out at 8:03 on the 27th. Someone from City -- the inner circle, the

staff, printed that post out before the end of the day, less than four hours.

there is an IA investigation as to who posted that photo. It is an active investigation, so we're

not going to talk about it, but yes, it is. Is it not?

City Attorney Ramos: That's correct.

(COMMENTS MADE OFF THE RECORD)

Commissioner Keon: According to...

City Attorney Ramos: But not the letter, the post.

Commissioner Keon: According to the City Attorney, the post is being investigated by IA.

(COMMENTS MADE OFF THE RECORD)

Commissioner Keon: I don't know anything about it.

Mayor Valdes-Fauli: Okay.

Commissioner Lago: Wait, wait, wait. I don't -- wait a minute. I don't want to end -- I'm not

going to end -- can you give me a...

Mayor Valdes-Fauli: Go ahead, go ahead.

Commissioner Lago: I mean, again...

Commissioner Keon: It is being investigated.

Commissioner Lago: Can you explain to me exactly what you mean by that? I'd like to know

because...

Mr. Baublitz: There was a social media post...

Commissioner Lago: Yes.

Mr. Baublitz: And there was a legal affairs post...

Commissioner Lago: Yes.

Mr. Baublitz: Where that is being investigated by Internal Affairs. But, the actual anonymous

letter that was sent to the City Manager, we have requested -- the women have requested in

Internal Affairs that that be investigated, who sent it.

Commissioner Lago: Okay.

Mr. Baublitz: And the City's refusing.

Commissioner Lago: Perfect. Excuse me, Madam City Attorney.

City Attorney Ramos: Yes, sir.

Commissioner Lago: I would like a response in regards -- because I would like to clarify -because you have to be very, very careful in front of so many people, especially with so many media outlets here when you make comments and there's no factual basis behind it. So, is the letter, the anonymous letter, being investigated, which was supposedly requested by the 14 female officers to be investigated?

City Attorney Ramos: No, sir.

Commissioner Lago: Okay.

City Attorney Ramos: What is being investigated is the post...

Commissioner Lago: Okay.

City Attorney Ramos: And it is an open IA investigation.

Commissioner Lago: And my follow-up question is a simple one. Why?

Commissioner Keon: Why don't we investigate anonymous letters?

Commissioner Lago: No, no, no, wait.

Commissioner Keon: Is that what you're asking?

Commissioner Lago: But I'm not...

Commissioner Keon: I'm just asking for clarity.

Commissioner Lago: Madam...

Commissioner Keon: Are you asking why...

Commissioner Lago: I'm asking why don't we invest -- excuse me. My question is --

remember, be careful because...

Commissioner Keon: No, I'm asking...

Commissioner Lago: November...

Commissioner Keon: I just want clarity.

Madam Commissioner, excuse me. Commissioner Lago: Just wait, wait. Remember,

November 2017, I said it very clearly, today it's the Chief; tomorrow, it's one of us. Do not do

this. Do not investigate anonymous posts. My phone number is 305-303-0115. Call me. Come

and speak with our City Attorney. Come and speak with our Clerk. Come and speak with my

colleagues and we can discuss this if there is really any basis behind this. My question is...

City Attorney Ramos: Yes, sir.

Commissioner Lago: Why are we investigating the post and not investigating the letter. That's

why I want to find out. Why is that?

City Attorney Ramos: Sir, I have to defer to the Administration on that. That decision was not

made by my office.

Mayor Valdes-Fauli: Alright.

Commissioner Lago: But I'm...

Mr. Baublitz: May I, Commissioner?

Commissioner Keon: Because you don't...

Mr. Baublitz: May I?

Commissioner Keon: Want to chill people from making a complaint. And sadly, sometimes

they may be inappropriate...

Mayor Valdes-Fauli: Not anonymous complaints.

Commissioner Lago: Commissioner...

Commissioner Keon: But oftentimes, they are. And so...

Commissioner Lago: Commissioner, let me...

Mayor Valdes-Fauli: Anonymous complaints are...

Commissioner Lago: Hold on.

Mayor Valdes-Fauli: Repugnant and...

Commissioner Lago: But let me...

Mayor Valdes-Fauli: They should be investigated.

Commissioner Lago: My question was not asked. We are investigating an anonymous post, but

you just said right now we don't investigate anonymous letters, but we investigate an anonymous

letter to basically put us in this situation in regards to Ed Hudak. Why are we not doing the same

thing for the 14 female officers? That's what I'm confused about.

(APPLAUSE)

Commissioner Keon: But you are.

(APPLAUSE CONTINUES)

Commissioner Lago: That's why...

Commissioner Keon: But you are.

Commissioner Lago: That's why -- and that's why we have problem, and that's why we're here

today.

Mayor Valdes-Fauli: Yeah.

Commissioner Lago: Because...

Commissioner Keon: You are.

Commissioner Lago: Because I told you very, very clearly, in November 2017, don't do this.

It's going to lead us down a hole...

Mayor Valdes-Fauli: Yeah.

Commissioner Lago: That's going to go nowhere, and it's going to just tarnish everyone. And

right now, you have 14 women that have not been contacted, that have -- we have not met their

goals. They're out there flailing in the wind and its one issue after another. They continue to be,

in my opinion, assaulted. Because if you look at what happened on Channel 4 the other day, it

was embarrassing, the fact that they took a video -- someone took a video that I saw of that party,

of that get-together, whatever it was, and they pixelated, on purpose, one of the female officers to

make it seem as if she was nude. And then that not only hit the TV, but that also hit the Herald,

because they ran an online article saying she was topless. So, I mean, guys, I understand -- we

may have difference of opinions in regards to the Chief, and I respect everyone's opinion. But

women are falling by the wayside. Again, we need to be very, very careful. These are the men

in blue. And when I mean men, I mean women and men, excuse me. We are not doing justice

by these women. And I have a bunch of different comments, but I have the ability and the

respect to refrain and discuss this another day, if you'd like.

Mayor Valdes-Fauli: Okay.

Commissioner Lago: I don't have a problem with that. But we can't investigate the Chief,

spend \$50,000, and then not follow up on the women. It's just...

Commissioner Keon: But...

Commissioner Lago: I think it's embarrassing. I mean, I don't know if you agree with me or

not. I mean, am I the only one? I think it shines a terrible light on the City, and I'm actually

embarrassed by that. I mean, does anybody...

Mayor Valdes-Fauli: No. I think you're right.

Commissioner Lago: Agree with me? I mean, listen, if you disagree with me, then I will accept

it. And I will say, you know what, you're right. Maybe I'm looking at this in the wrong fashion

or the wrong manner, but educate me. I'm not a lawyer.
